Immediately, a strong police team of CCP-PS lead by SI B. Zairemthang rushed towards Vajing village, along Teddim road and set up one vehicle Check point (NAKKA). In the meantime, a requisition for deputing one Executive Magistrate to be present while conducting Frisking and Checking was submitted to Deputy Commissioner, Churachandpur. Immediately, one Executive Magistrate namely Thangkhohao Haokip SDC/SAIKOT was deputed for Magisterial Duty by Deputy Commissioner, Churachandpur.


