I have the honour to report that, today the 13<sup>th</sup> June, 2026 at around 11:50 am received a reliable information that an unknown person is transporting contraband items suspected to be brown sugar at S.Paukhozam Road in the general area of Headquarter veng, CCPur. Without delay the information was intimated/informed to the SP-CCP, who instructed that a strong police team be formed to take necessary action. Accordingly, a police team from CCP-PS, led by ASI K. Paumuansang, immediately proceeded to S. Paukhozam road, located at Headquarter veng, area, and set up a vehicle check-post (NAKKA).

In the meantime, a requisition was submitted to the Deputy Commissioner, Churachandpur, for deputing of an Executive Magistrate to be present during frisking and checking. In response, the Deputy Commissioner deputed Shri.Thangkhohao Haokip SDC/SAIKOT for magisterial duty.

While conducting frisking and checking at S.Paukhozam road, Headquarter area, one Alto vehicle was found moving in a suspicious manner was intercepted. On thorough checking, 7 plastic packets containing 11 soap cases each total: 77 soap cases, suspected to be contraband (Suspected brown sugar), were found concealed inside a nylon-sack within the vehicle. The 77 soap cases were weighed using a weighing machine and found to weight 3127 grams (Including the weight of the soap cases) of the suspected brown sugar. The 7 plastic packets were marked as A to G.

The individual is later identified as Mr. Thongkhosei Haokip (44) years s/o Late Jamlhun Haokip of Molnoi Pallel, Tengnoupal District, Manipur, and presently residing at Deilhenphai village, CCPur. The

white Alto Car, bearing registration No. WB19G-8906 (With key), used for carrying the illegal contraband, one nylon-sack and one mobile phone i.e., Redmi 12 (5G) bearing IMEI Nos.:863199063282541/863199063282558 and having mobile No.: 8415958294 were seized along with the contraband at 12:30 pm, in the presence of the Magistrate and witnesses. The suspected accused, Mr. Thongkhosei Haokip s/o Late Jamlhun Haokip of Molnoi Pallel, Tengoupal District, Manipur A/P: Deilhenphai village, CCPur was arrested at the spot at 12:40 pm.




