



On 12/05/2026 at 04:30 p.m, one complaint namely S. Khalatza of Sihai Khunou Village reported to this Police Station stating that on 12/05/2026 at around 12:15 p.m., he (the complainant) was physically assaulted by (1) Mr. Chipemmi Shimray, (2) Mr. Michael Shimray, (3) Angelus Shimray and 17 (Seventeen) others by using sophisticated weapons like sharp stones and clubs thereby leaving him grievously injured on his head and face. In connection with the report, a GD Entry No. 15/UKL-PS/2026 Dated 12/05/2026 was registered to verify the facts and circumstances of the incident.

During the course of the enquiry, prima facie evidence could be made out against the accused persons. Base on the complaint report lodged by the victim and on the basis of the result of the enquiry, the GD Entry No. 15/UKL-PS/2026 Dated 12/05/2026 is converted to regular FIR No. 06(06)2026/UKL-PS U/S 117/131/3(5) BNS, 2023 for investigation.


