One column of 5 Assam Rifles was launched to establish Mobile Vehicle Check Post between Songpi to Hengkot by 1930 hours. At around 2030 hours a truck approached the Mobile Vehicle Check Post. It was stopped and all pers were asked to dismount to carry out the check. The individual tried to escape while dismounting from vehicle but was overpowered and apprehended after a brief physical scuffle. 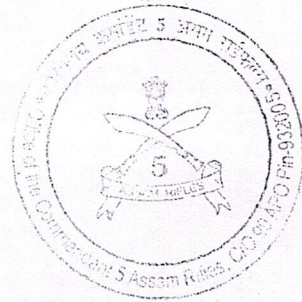

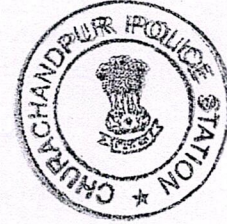
