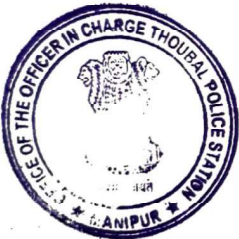

I have the honour to report that, today i.e. 23/05/2026 at around 5.00 pm, my Scooter Honda Activa 4G, b/regn.no. MN01AD4859, Ch/No. ME4JF507GH7246060, Eng/No. JF50E75246144 and Trance blue metallic in colour which was registered in the name of one Md. Hefajuddin S/o Md. Abdullah of Lilong Turel Ahanbi, Chingkhamb Mathak, Thoubal was found stolen away by unknown person (s) while kept parked under proper locked in front of Wangjing Bazar Thoubal along NH-102 and was unable to trace out till date upon various contacts made.
