Today i.e. 29-05-2026 at around 2:40 pm, received information that on the same day at around 2:30 pm, one Tata Magic bearing registration No. MN06L6866 driven by an unknown driver proceeding towards Imphal side from Thoubal side collided with one Hyundai Venue car bearing registration No. MN04P2608 driven by an unknown driver proceeding from opposite direction by crossing the road median along NH 102 at Tangieng. As a result, both the drivers along with three occupants of the Tata Magic and one occupant of the Hyundai Venue sustained injuries and were evacuated to District Hospital, Thoubal for medical treatment. Both the vehicles were also badly damaged. Hence the case.
