Today i.e. 31-05-2026 at 5:55 pm, received information that on the same day at around 5:45 pm, one Yamaha FZ bearing registration No. NIL ridden by an unknown rider coming from Wangjing towards Imphal side dashed into a swift car bearing registration No. WB08A8268 driven by an unknown driver while the said car was attempting to merge onto NH 102 from Khangabok Bangshibudon road along NH 102 at Khangabok Bazar due to rash or negligent riding on the part of the unknown rider of Yamaha FZ. As a result, the rider and one pillion rider of Yamaha FZ sustained injuries on their persons and were evacuated to Hospital for medical treatment. Both the vehicle were also partly damaged.
