First Information contents: Today i.e. 2/6/2026 at about 1pm, a crowd of women folks who are shopkeepers and vendor stall owners of Thoubal market numbering around 300 created an unruly mob and stormed at Municipality Office located at Thoubal Wangmataba thereby demanding to withdraw the shop licence allotted to Vishal Mega Mart located at Thoubal Achouba near District Transport Office. The police teams comprising of women police deployed there gave ample warnings to disperse the unruly mob. In spite of repeated police warnings, the mob turned violent and aggressive towards police team. The mob attempted to forcefully enter the Municipality Office premises by pushing through the police cordon. During the incident, the mob obstructed and assaulted police personnel who were discharging their lawful duties. As a result, two police personnel sustained injuries and were immediately shifted to the hospital for medical treatment. Subsequently, with the assistance of additional police force, the mob was dispersed at about 3:00 PM and the situation was brought under control. Hence the case.
