Sir,

I have the honour to report that today i.e. 4/6/2026 at about 9:20 am, I went to my paddy field located at Wangbal Ningthem Loukol on my scooter Honda Activa decent blue in colour bearing regn. no. MN04H2689, chassis no. ME4JK362LSW462727 and engine no. JK36EW2462766 worth Rs. 1,15,000 (one lakh fifty thousand) which is recorded in the name of my wife Laishram Sunibala Devi w/o Laishram Brojendro Singh of Khangabok Part I Awang Leikai for inspection of ploughing works after my scooter was parked at Wangbal Canal near culvert near Ningthem Loukol with proper lock. The distance between my paddy field and vehicle parking area would be around 200 meters. At about 11:20 am, I saw one unknown person stealing my Honda Activa and riding towards Uyal village side while I was standing at my paddy field. I could not trace my vehicle as there was no means to chase the culprit at the moment. The relevant documents of the said Honda Activa including some personal documents were also put inside its toolbox.

It is therefore, requested to take up necessary action in this regard.
