Sir,

I have the honour to report that on 11/6/2026 at about 9:30 pm, I left my home and proceeded to the UFO Shanglen, Thoubal Kshetrileikai for watching FIFA World Cup match on my scooter Honda Activa gray in colour bearing regn. no. MN01AN5313, Chassis no. ME4JK156CPW075498, engine no. JK15EW5075034 worth Rs. 1,00,000 which is recorded in the name of myself and upon arrival, I parked the scooter in front of the premises of the UFO Shanglen and locked it properly. However, when I came out of the Shanglen at around 2:00 am of 12/6/2026, I found my scooter missing from the parking area. I have searched thoroughly around the area, but it remains untraceable. I strongly suspect that my vehicle has been stolen by an unknown person.
