Sir,

I have the honour to report that, one Scooter/vehicle Honda Activa 5G bearing the following details: Registration No. MN01AH8514, Chassis No. ME4JF50AEKA012917, Engine No. JF50EA0012925, Model-2019 & Colour: T Blue Metallic, recored/Registered in the name of my father- Athokpam Janmenjoy Singh S/o late A. Kullabidhu Singh of Thoubal Athokpam Mayai Leikai, Thoubal.

On 15/06/2026 at around 9.00 am, I parked the above mentioned Scooter along the roadside of Athokpam Makha Leikai Pat Lambi under proper lock and went to attend my personal work. When I returned at about 4.00 pm, I found that the Scooter was missing from the place where it had been parked. I immediately searched in the surrounding area but the Scooter could not be traced. It is learnt that unknown person have stolen away the Scooter. The approxiamate value of the said stolen vehicle is Rs. 50,000/- only. The RC book (smart) of the said vehicle was also included inside its compartment box while stealing. The report could not be submitted in time due to ongoing search for the stolen vehicle.
