Sir,

I have the honour to report that I am the owner of one EECO Van, silky silver in colour, bearing registration No. MN03A-4884, Chassis No. MA3ERLF1S00837111, Engine No. G12BN827062, 2020 model, which stands registered in the name of Mrs. Amina, W/o Muhammad Ali of Sangaiyumpham Cherapur Mayai Leikai, Thoubal. Today i.e. 20/06/2026 at around 1:45 pm, my vehicle had been kept at a motor workshop namely Sangaiyumpham Salam Makok Workshop, owned by Md. Nasimuddin, aged about 56 years, S/o Md. Tamejali of Sangaiyumpham Salam Makhok, located at Sangaiyumpham Salam Makhok for repairs. On the same day, i.e. on 20/06/2026 at about 2:00 pm, the said EECO Van was taken by two individuals, namely Md. Ajmir, aged about 26 years, S/o (L) Md. Hussain of Sangaiyumpham Nungphou Mamang Leikai, and Md. Nawaz Khan, aged about 27 years, S/o Md. Nahakhan of Sangaiyumpham Mairenkun Mayai Leikai, who are mechanics of the said workshop, to purchase spare parts at Khangabok area. While they were purchasing spare parts from the shop of one Romen Motors Spare Parts located at Khangabok Sanilou near Sur Hospital, after parking the vehicle near the shop, it was found stolen by some unknown persons on the same day at around 2:30 pm. The approximate value of the EECO Van is Rs. 3,70,000/- (rupees three lakh seventy thousand) only.

It is therefore, requested to kindly take up necessary legal action to trace out the stolen vehicle.
