Subject: Report



Sir,

I have the honour to report that on the night of 20/06/2026, an argument broke out between my wife and my daughter-in-law Ningthoujam (O) Pushpa Devi. The dispute arose due to a delay in providing information regarding a Chura Karan ceremony involving my daughter-in-law's parental relatives. Following this incident, my daughter-in-law frequently argued with my wife. Today i.e. 24/06/2026 at around 11:00 am, my daughter-in-law's father Mayanglambam Surjit Singh aged about 55 years, a resident of Kakching Wairi Kamla Pareng, accompanied by Seram Siroy Singh (a parental relative of my daughter-in-law) from Kakching Wairi, Seram Suraj Meitei aged about 35 years s/o late S. Ramkeshore Singh of Kakching Kamla Pareng, Mayanglambam Tamphasana Devi (elder sister of my daughter in law) of Kakching Wairi Kamla Pareng and 4 to 5 unidentified individuals came to my house. Without any valid reason, they physically assaulted my son Ningthoujam Kirankumar Singh 35 years and my daughter Ningthoujam Chanchan Devi 23 years inside my courtyard.

As a result of the assault, both my son and daughter sustained injuries. They were taken to the District Hospital, Thoubal for medical treatment.

It is therefore, requested to take necessary legal action in this regard
