Sir,

With due regards, I beg to state that today i.e. 23/06/2026 at about 04:15 p.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at Heirok Part-II, Chingdompok area for using offensive act against State Security Forces and CAPF.

On receipt the information, joint team of Commando Unit, Thoubal led by Insp. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, MPS, Addl. SP(Ops) Thoubal and under the overall supervision of Shri. Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal have rushed to the spot immediately and launched a massive operation at 06:00 pm. After a thorough search a suspected site and the undernoted items were found from the spot and seized at 06:27 pm by observing formalities.
