Sir,

I am to state that on 26/05/2026 at around 06.30 pm one Honda Activa 125 DISC OBD2B, Ground Grey in colour bearing registration No. MN04H3152, having Chassis No. ME4JK430DTW428656 and Engine No. JK43EW0463130, registered in the name of my self was found stolen by some unknown miscreants from the road side of the IVR of Wangjing-Tentha, just near the shop of Maibam Kumar Singh, 70 years S/o Late M. Dhananjoy Singh located at Tentha Khongbal, while the vehicle was parked at the said place under proper lock and key and the same was untraceable in spite of vigorous search. 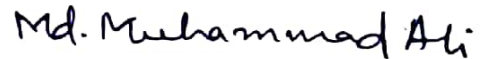
