Today, i.e., 05/06/2026, at about 10:55 pm received an information that on the same day at about 10:45 pm, one bomb suspected to be a hand grenade exploded in the courtyard of one Moirangthem Subol Singh, aged about 55 years, S/o Late M. Angou Singh of Tentha Khunou, with the intention of threatening his family life and property. As a result of the explosion, some window panes of his house were damaged. However, no report of any human casualty or injury has been received.
