Sir,

With due regards, I beg to state that today i.e. **02/06/2026** at about **04:00 a.m.** we received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at foot hill of Pechi Chinglak for using offensive act against State Security Forces and CAPF.

On receipt the information, joint team of Commando Unit, Thoubal led by Insp. K. Nitaranjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, MPS, Addl. SP (Ops) Thoubal and under the overall supervision of Shri. Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal and a column of 31 AR and column of 165 TA have rushed to the spot immediately and launched a massive operation at **04:30 a.m.** On searching and found the undernoted articles from the spot and seized at **05:04 a.m.** by observing formalities.
