During the spot visit, the Iron Grill Fence length about 5 meters fixed on the road side of NH-102 was found cut and lost. Moreover, some residue of welding rods and metal slag were found near the spot. Accordingly, the residue of welding rods and metal slag were seized from the spot on the same day at 3.23 pm.
