The brief fact of complaint report is that on 06/06/2026, Bijesh Singha (41) S/O Lakhi Babu Singh of Diphu Sarthe Terand Colony, PO/PS-Diphu, Karbi Anglong District, Assam filed a complaint report to SP/Thoubal stating that he is the owner of Maruti Suzuki Swift VXI, Magma Grey color registered in his name bearing Engine No. Z12EP12302, Chassis no. MBHZCDESKSD332257, registration no. AS09L7191. That the said four wheeler was taken by one of his friend namely Md. Masleuddin Shah S/O Md. Mohd. Ali Shah from Lilong Bazar at Imphal.

That, it has come to light that while the said person Md. Masleuddin Shah while driving at Lilong Turel Ahanbi in the month of January 2026, the above mentioned four wheeler was forcefully theft by the accused person namely Md. Abdul Hamid @ Ithem (40) S/O Md. Abdul Samar, a resident of Lilong Turel Ahanbi Ubak Thong PO & PS Lilong, Thoubal District, Manipur.

That, through reliable source it is now discovered that the said lost four wheeler is lying at Babloo Workshop near Amina Hospital Lilong.

Hence he would like to request to give direction to the OC/Lilong PS to recover the said four wheeler without further delay and lodge a FIR against the accused person for ends of Justice.

The same was endorsed to me for conducting a smooth enquiry into the matter. Accordingly self-have made a discrete enquiry into the matter. On enquiry, the said Maruti Suzuki Swift VXI Magma Car was found lying at the Babloo Motors, Lilong Epham Leikai and on enquiry to the workers of the workshop, they revealed that the said Maruti Suzuki Swift car was brought by one Md. Abdul Hamid @ Ithem S/O Md. Abdul Samat of Lilong Turel Ahanbi Ubak Thong for repairing. Hence, the Maruti Swift car was brought at Lilong Police Station.

In the line of enquiry, notice U/S 94 BNSS has been served to Md. Abdul Hamid @ Ithem S/O Md. Abdul Samat of Lilong Turel Ahanbi Ubak Thong to produce proper documents of the Maruti Swift car to prove the ownership. However he didn't turn up at LIL-PS and didn't produce any document to prove him as owner of the said Maruti Swift car. The register owner of the Maruti Swift car is Bijesh Singha S/O Lakhi Babu Singh of Diphu Sarthe Terand Colony, PO/PS-Diphu, Karbi Anglong District, Assam.

Hence, it is well established that Md. Abdul Hamid @ Ithem S/O Md. Abdul Samat of Lilong Turel Ahanbi Ubak Thong have committed the offence of snatching & theft with criminal intimidation as he snatched the Maruti Swift car bearing Regd. No. AS09L/7191 forcibly from Md. Masleudin Shah S/O Md. Mohd. Ali Shah from Lilong Bazar at Lilong Turel Ahanbi in the month of January 2026.

It is therefore requested to kindly take up necessary legal action against the culprit as per provision of law.
