I, Naorem Prista Devi, daughter of Naorem Ibochoubi Singh, residence of Kwakeithel Thiyam Leikai, near St. Peters school, PO-Imphal, PS-Lamphei-795001, wish to lodge a complaint regarding the loss of my scooty.

That, yesterday, i.e. 01/05/2026 at around 10:00 am I parked my scooty, Model Name-Activa DLX, Registration No: MN01AN7940 (registered in the name of my younger sister namely Naorem premika Devi) Chassis No: ME4JK156JPW348378, Engine No: JK15EW5348249, Colour: Gray at the gate of Narcotics Control Bureau Office, Changangei Uchekon, Impahl West. When I came out from NCB Office at around 6:00 pm, I discovered that my scooty was stolen away by unknown person. I searched the surrounding area and inquired with nearby vendors and shops but I have not been able to locate it. Then I requested our NCB Staffs to check the CCTV footage where my scooty was located. After checking the CCTV footage, it is found that two persons had taken away my scooty. In the CCTV footage it was found that one person was kept to watch the area and whereas the other person wearing a hoodie jacket believed to have technical knowledge of unlocking the key of scooty has driven away within a time span of few minutes. And the other person watching the scene was allowed to sit as pillion rider and driven away the scooty on the northern side towards Keishampat road.
