Subject: - Report.

Sir,

I have the honour to state that today i.e. 09/05/2026 at about 01:10 pm, a reliable information was received from our own source and further corroborated from the information input provided by 31 AR regarding the presence of some active cadres of KCP (Nongdrenkhomba) organization (a faction of KCP organization), an outlawed banned organization, in and around Langol Game Village area under Lamphel PS with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Langol Game Village Zone-II area. During that one suspected person was detained at Langol Game Village Zone-II for verification. On spot verification, the detainee identified himself as Thiyam Inao Singh (33 yrs.) S/o. Thiyam Mani Singh of Kumbi Makha Leikai, Bishnupur District, Manipur a/p at a house located at Langol Game Village Zone-II.

During preliminary verification, he disclosed that he is an active member of KCP (Nongdrenkhomba) organization (a faction of KCP organization) and started working for the said organization since the year 2023 through one Hero of KCP (Nongdrenkhomba) organization from Takhel area.

Hence, he was arrested from the spot i.e. from Langol Game Village Zone-II at 02:42 pm by observing formalities.

From his possession, (i) one OPPO Reno7 Pro 5G mobile handset along with two SIM cards i.e., (a) one Airtel SIM card bearing mobile no. 8415848447 (as disclosed by him) and (b) one BSNL SIM card bearing mobile no. 9436840415 (as disclosed by him), (ii) one Aadhaar card bearing no. 7960 2323 0656 and (iii) one ID card bearing No. 19/KIYDO/RC/2024 were seized at the spot at 02:47 pm by observing due formalities.

After thorough verification, the arrestee disclosed that on 04/05/2026, he received two grenades and some ammunitions from two unknown persons sent by one s/s Chairman Nongdrenkhomba of KCP (Nongdrenkhomba) organization. He further disclosed that he kept concealed the above-mentioned grenades and ammunitions in a bush near the fencing wall of the house located at Langol Game Village Zone-II (the house where he is currently staying) for the purpose of committing prejudicial activities. As pointed out by him, the following articles were recovered in a bush near the fencing wall of the house located at Langol Game Village Zone-II:

- (i) 2 (two) nos. of No. 36 HE hand grenade with two detonators,
- (ii) 15 (fifteen) nos. of 9mm ammunition and
- (iii) 1 (one) white plastic polythene bag.

The above recovered grenades, ammunitions and plastic polythene bag were seized at the spot i.e., near the fencing wall of the house located at Langol Game Village Zone-II at 05:46 pm by observing due formalities.

Hence, the arrested person and the above seized articles are handed over to you for taking further necessary legal action.

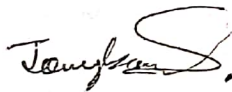
