Sir,

I have the honour to report that today i.e. 10th May, 2026 at about 4:00 am an information was received from our reliable source about presence of some miscreants are loitering in the Langol hill range, Imphal West District. Acting on the said input, a combined team comprising personnel of City Police Station-IW, CDO-IW and a column of 33 AR, under the command of Inspt. N. Gokulchandra Singh, OC-City-PS Unit under the supervision of Shri. Rojit Irom, MPS Addl. SP (L&O) IW and under overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area. On reaching the vicinity of Khundi Kabui village cemetery, Langol hill range, Imphal West. The teams conducted search operation at the suspected places located in the adjoining areas from 4:30 am. During the search operation the combined team recovered the undernoted Arms and Ammunitions which were found concealed underground in plastic sacks. It is suspected to be hidden by some unknown miscreant with the intention of prejudicial activities for demanding ransom and planning to attack.

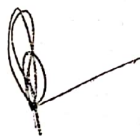
