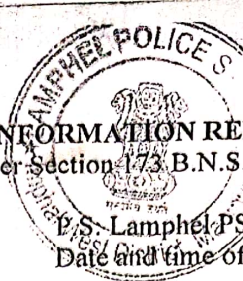

Subject: Report

Sir,

Sir. As per endorsement vide RR. No. 194/LPS/2026 dated 03/04/2026, I have conducted as discreet enquiry. During the enquiry, I have examined the complainants. The complainant, (1) Mayanglambam Hero Singh (30) S/o M. Ranjan of Tera Lukram Leirak stated that his 3 (three) horses has been stolen/lost from Takyelpat near CRPF Camp when they were kept for grazing in the month of November-December, 2025. The suspected accused persons Sanasam Ranjan, Angom Kishan and Moirangthem Devachandra have admitted to have stolen one of the horses. The complainant (2) Akoijam Manaobi Meitei (60) S/o (1) Ak Kula Meitei of froishemba Alusjam Leikai stated that he lost his 1 horse around October November, 2025 from iroishemba Zoo area then later 3 horses from iroishemba Mela Ground and then 5 horses from freeshemba Zoo area. The suspected accused persons Sanasam Ranjan, Angom Kishan and Mourangthem Devachandra have admitted to have stolen the horses from iroishemba Zoo area. The complainant (3) Salam Ngounu Chanu (49) W/o Bismark Ahanthem of Keishamthom Ahanthem Leikai stated that she lost her 1 horse around December, 2025. The horse was kept at a stable at AMPA ground near iroishemba Zoo under the care of one of the suspect Akoijam Ibomcha. He stated that the horse is still under his care but she haven't seen the horse again. The complainant (4) Kayenpaibam Pandit Meitei (38) S/o K. Lokendro of Ngairangbam A/p Langol Type II Sajaan Sanglen representative of Universal Polo Club lost two horses at the end of December, 2025. He stated that one day in Dec 2025, Akoijam Ibomcha called and said his horses were seen around Iroishemba zoo area and were not seen again. Later the suspected accused persons Sanasam Ranjan, Angom Kishan and Moirangthem Devachandra have admitted to have stolen the horses under Akoijam Ibomcha's instruction. Representative of Universal Polo Club, Saranthen Tanglounanba Meitei (44) S/o S. Thambal of Bishnupur Toubul A/p Langol Type II Sajaan Sanglen and Yaikhom Johnson Meitei (28) S/o Y. Shyam of Lanmeidong A/p Langol Type II Sajaan Sanglen have lost 1 horse and 2 horses respectively in the similar manner. Another representative of Universal Polo Club, Mayanglambam Henery Meitei (28) S/o M. Herachandra of Pallel Maning Leikai A/p Langol Type II Sajaan Sanglen stated he had given 1 horse to Akoijam Ibomcha for training but the horse was lost in 1 week of December, 2025 from Ibomcha's custody. The complainant (5) Khundongbam Deventy Devi (38) D/o Kh. Mijao of Porompat Thawanthaba Leikai stated that she lost 13 horses. On 02/11/2025, one Robert and jamini (detail not known) saw Ibomcha take 5 of her horses from Takyel area. Further she suspects Ibomcha of stealing 1 horse on 14/11/2025 and another 7 horses on 27/11/2025 & 28/11/2025 from NIT Langol area. The complainant (6) Chungkham Sunilkumar (44) S/o Ch. Dhananjoy of Tera Loukrakpam Leikai stated he had lost 5 horses, Ibomcha had stolen some of his horses on previous occasion and he recovered them. There is no other suspect other than Ibomcha who could be responsible for the lost of his 5 horses. The complainant (7) Lisham Olympus (28) S/o (L) L. Maimu of Naoremthong Takhellambam Leikai, representative of Krypsa Polo Team stated that his club lost 9 horses from Langol Game Village near Mary Kom Academy. He stated he heard from Khundongbam Deventy's staff that their horses were taken by Ibomcha and associates. His associates Sanasam Ranjan, Angom Kishan and Moirangthem Devachandra have admitted to have stolen the horses. The complainant (8) Pukhrambam Ibungnomacha (44) S/o (L) P. Manihar of Uripok Khumanthem Leikai stated he lost 6 horses from Takyelpat near CRPF Camp and suspect Ibomcha and his associates might have stolen the horses. The complainant (9) Elangbam Romesh Singh (45) S/o (L) E. Kunjabihari Singh of Khurai Chingangbam Leikai stated that he lost 1 horse from froishemba Zoo area. He had seen his horse last in October, 2025. He called Ibomcha in last week of November 2025 to ask whether he had seen his horse. Ibomcha's reply led him to suspect that he must have stolen his horse. The complainant (10) Khangjarakpam Sarjit (48) S/o (L) Kh. Ibotombi of Langjing Achouba stated he lost 16 horses from Takyelpat near CRPF Camp and he heard from Ibomcha's associates that they have taken the horses. The complainant (11) Sairem Somorjit Singh (37) S/o (L) S. Bheigya Singh of Langjing Achouba stated he lost 5 horses from Takyelpat near CRPF Camp. On 31/12/2025, he checked the horses and found they were grazing at Takyel and on the next day when he check again, the horses were found missing from the grazing area. Ibomcha's associates admitted to have stolen the horses. The complainant (12) Thoudam Kaoba (42) S/o (L) Th. Jadhoo of Kongpal Kshetri Leikai stated he lost 4 horses from Takyelpat near CRPF Camp, 2 in October-November, 2025 and 2 in December 2025. Someone had seen Ibomcha taking his 1st 2 horses and when confronted, he lied about the whereabouts and later his associates admitted to

have stolen the later 2 horses. The complainant (13) Swarnakumar Kangjam (30) S/o Shrikumar Kangjam of Uripok Takellambam Leikai stated that he lost 1 horse from Iroishemba Zoo area, it was last seen in 1 week of December 2025. Someone saw his horses taken by Ibomcha and later his associates admitted to have stolen the horses. The complainant (14) Khwairakpam Meghajit (60) S/o (L) Kh. Bokul of Thangmeiband Meisnam Leikai stated that he lost 2 horses around November-December 2025 from Langol Game Village near Mary Kom Academy. He used to hire Ibomcha to tame his horses in previous occasions. He suspect Ibomcha and his associates might have stolen his horses.

As per the statements of the complainants, they could not identify exactly from where the horses were stolen. However, the horses were always grazing at Langol, Iroishemba and Takyel grazing field.

However, on examination of the suspected accused persons Akoijam Ibomcha Meitei (45) S/o Ak. Itocha of Iroishemba Mayai Leikai and his associates namely, Sanasam Ranjan (22) S/o Bhogen Singh of Lamsang Lamdeng Khunou, Angom Kishan (19) S/o A. Karna Singh of Thangmeiband Iouring Pural Leikai and Moirangthem Devachandra (22) S/o M. Sanahal of Mayang Langjing have denied the charges. They are required to be examined thoroughly. It is therefore requested to register a regular FIR for smooth investigation of the case.
