I have the honour to state that today i.e. 11/05/2026 at about 02:00 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of KCP organization, an outlawed banned organization, in and around Tarung area under Lamphel PS with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Tarung Grace Colony area. During that one suspected person was detained at Tarung Grace Colony for verification. On spot verification, the detainee identified himself as Khumbongmayum Ananda Meitei (53 yrs.) @ Lamphel @ Ibomcha S/o. (L) Kh.
