Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Langol Laimanai area. During that one suspected person was detained at a house located at Langol Laimanai for verification. On spot verification, the detainee identified himself as Khulem Shyam Singh (23 yrs.) S/o. Khulem Samananda Singh of Kongpal Chingangbam Leikai, Imphal East District, Manipur a/p at the residence of his mother-in-law located at Langol Laimanai, Imphal West District, Manipur (where he was detained).

During preliminary verification, he disclosed that he is an active member of KCP (PWG) organization (a faction of KCP organization) and started working for the said organization since January/February, 2026 through one Arunjit (Ph. no. 9233984640) of KCP (PWG) organization from Yaingangpokpi area who is presently staying in Nepal. He also disclosed that he is presently working under the command of one s/s Commander SK @ Inaocha (Ph. no. +917085733815) of KCP (PWG) organization from Pukhao area who is presently staying in Nepal. He further disclosed that under the instruction of his commander, he along with his associate namely one Tondonba (Ph. no. 9402742896) from Kongba/Wangkhei area was involved in serving monetary demands/threats to schools in valley area for raising their party fund.

Hence, he was arrested from the spot i.e. at the residence of his mother-in-law located at Langol Laimanai at 05:00 am by observing formalities.

From his possession, (i) one Redmi 9 mobile handset along with one Airtel SIM card bearing mobile no. 9612118631 (as disclosed by him), (ii) one vivo Y36 mobile handset without SIM card and (iii) one Aadhaar Acknowledgment receipt bearing Update Request No. 2009/14003/21858 were seized at the spot at 05:06 am by observing due formalities.

Hence, the arrested person and the above seized articles are handed over to you for taking further necessary legal action.

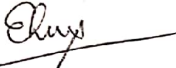

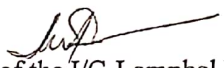
