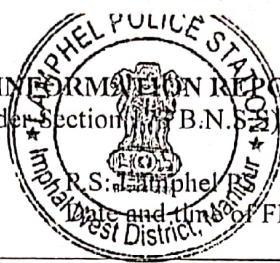

First Information contents



Subject: - Report.

Sir,

I have the honour to state that yesterday i.e. 12/05/2026 at about 10:00 am, a reliable information was received from our own source and further corroborated from the information input provided by 31 AR regarding the presence of some active cadres of KCP organization, an outlawed banned organization, in and around Langol area under Lamphel PS with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meitei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Langol Game Village area. During that five suspected persons were detained at Langol Vista Cafe, Langol for verification. On spot verification, the detainee identified themselves as: (i) Laishram Ranjit Singh (52 yrs) @ Tamnganba @ Apik @ Loya S/o. (L) L. Achoubi Singh of Yurembam Awang Leikai, Imphal West District, Manipur, (ii) Oinam Somenchandra Singh (42 yrs) @ Macha @ Moirangjao @ Karangjao S/o. O. Rajen Singh of Thanga Karang Mamang Leikai, Bishnupur District, Manipur a/p at a quarter located at Langol Type-II, Imphal West District, Manipur, (iii) Arambam Birkumar (52 yrs) @ Kanba @ BK S/o. A. Gunamani of Sekmai Kanglatombi Mantriband, Imphal West District, Manipur, (iv) Maibam Tomba Singh (39 yrs) @ Loya S/o. M. Mangijao Singh of Tentha Khunjao, Thoubal District, Manipur and (v) Chabungbam Lamnganba Meitei (38 yrs) @ Wangba S/o.(L) Ch. Lokendro Meitei of Heibongpokpi Maning Leikai, Imphal West District, Manipur.

From the possession of Laishram Ranjit Singh the following articles were recovered: (i) one Redmi 9 Power mobile handset along with one Airtel SIM card bearing mobile no. 8131054632 (as disclosed by him), (ii) one Nokia keypad mobile handset along with one Airtel SIM card bearing mobile no. 8729872115 (as disclosed by him) and (iii) one Aadhaar card bearing no. 6263 8576 5779.

From the possession of Oinam Somenchandra Singh the following articles were recovered: (i) one Samsung Galaxy F17 5G mobile handset along with two Airtel SIM cards bearing mobile nos. (a) 9612792866 and (b) 8974267100 (as disclosed by him) and (ii) one Aadhaar card bearing no. 9237 8023 9132.

From the possession of Maibam Tomba Singh the following articles were recovered: (i) one Samsung Galaxy A36 5G mobile handset along with one Jio SIM card bearing mobile no. 6009298337 (as disclosed by him) and (ii) one Aadhaar card bearing no. 9092 0276 9205.

From the possession of Chabungbam Lamnganba Meitei the following articles were recovered: (i) one POCO C50 mobile handset along with one Airtel SIM card bearing mobile no. 9862471822 (as disclosed by him).

During preliminary verification, the detainee namely Laishram Ranjit Singh disclosed that he is presently working as s/s Founder Chairman of KCP (PWG) organization (a faction of KCP organization). The remaining four detainees also disclosed that they are active members of KCP (PWG) organization (a faction of KCP organization) and they are presently working under the command of the above mentioned s/s Founder Chairman Laishram Ranjit Singh of KCP (PWG) organization. On further verification, they disclosed that they were conducting a meeting at Langol Vista Cafe regarding their organization.

Hence, (i) Laishram Ranjit Singh, (ii) Oinam Somenchandra Singh, (iii) Arambam Birkumar, (iv) Maibam Tomba Singh and (v) Chabungbam Lamnganba Meitei were arrested from the spot i.e. at Langol Vista Cafe, Langol at 11:30 am, 11:32 am, 11:34 am, 11:36 am and 11:38 am respectively by observing formalities.

Due to the sensitiveness / vulnerability of the spot and by also considering the prevailing law & order situation of the said area, seizure of the above recovered articles could not be done at the spot. Later on, the arrestees and the above recovered articles were brought to the office of the CDO-IW, Minuthong for making seizure safely. Accordingly, the above recovered articles were seized at the office of the CDO-IW, Minuthong at 01:41 pm, 01:47, 01:54 pm and 01:57 pm by observing due formalities.

Due to unable to contact the family members, the information regarding the arrest of Arambam Birkumar could not be given to his family members. As nominated by the arrestee, the

information regarding his arrest was given to one Laishram Premkumar Meetei (Ph. no. 9862512269) S/o. (L) L. Achoubi Meetei of Yurembam Awang Leikai, Imphal West District, Manipur (elder brother of the arrestee namely Laishram Ranjit Singh). And Laishram Premkumar Meetei was also informed that the arrestee (Arambam Birkumar) will be handed over to Lamphel PS for taking further necessary legal action. Further, Laishram Premkumar Meetei was instructed to relay the said arrest information to the family members of the arrestee (Arambam Birkumar) and Laishram Premkumar Meetei was also instructed to make the family members of the arrestee (Arambam Birkumar) appear at Lamphel Police Station for further necessary legal procedure.

Hence, the arrested persons and the above seized articles are handed over to you for taking further necessary legal action.
