Sir,

With due regard and respect, I the undersigned have the honour to state few lines for your kind consideration and necessary action.

That, today i.e. 15/05/2026 at about 7:00 pm, I was checking CCTV camera while I was performing my duty at Security Room, Gym Khana, RIMS campus. I show two unknown persons came on Maruti Alto car (Silver in colour) bearing registration No. WB64F-2113, and proceeding toward Gym Khana parking side which is suspected to be stealing the vehicle. Again I continuously checked the CCTV camera, two persons tried to steal two wheeler vehicle Honda Activa 6G (Blue in colour) bearing registration No. MN10A-0110. Suddenly, I came out and chase them to catch but they fled away on their vehicle, Maruti Alto car (Silver in colour) bearing registration No. WB64F-2113. However, I informed to our Supervisor, MSS, RIMS namely Shamurailatpam Naocha (41) yrs S/o Sh. Mani of Sagolband Meino Leirak, IW and also he further informed to other security personnel to check/search the vehicle and continue search checking within the RIMS campus. During the searched, we found the vehicle Maruti Alto car (Silver in colour) bearing registration No. WB64F-2113 at CBI Gate, Qtr. Type-V without occupant and continued searched the occupant. On the same day at about 7:40 pm, the suspected two persons were detained for verification at Psychiatric Ward, RIMS. During the verification, they identified themselves as 1) Md. Soilhamid (22) yrs S/o Late Md. Mahamut of Madrassa Hamidiya, Lilong Haoreibi Makha Leikai, Thoubal District and 2) MD. Musharaf (25) yrs S/o Md. Nasir Khan of Lilong Chingkhram Makha, Thoubal District and they disclosed that they tried to steal the vehicle Honda Activa 6G (Blue in colour) bearing registration No. MN10A-0110 at GYM Khana, RIMS and their vehicle was parked at CBI Gate, Quarter Type-V. Later, we informed to the Lamphel Police Station and hand over the two accused persons and the vehicle Maruti Alto Car for further necessary.
