With due regard and respect, I the undersigned have the honour to state few lines for your kind consideration and necessary action.

That, yesterday i.e. 16/05/2026 at about 8:20 pm, one unknown vehicle car driven by unknown driver coming from Uripok side towards Iroishemba had dash my father namely Elenagbam Bhudhachandra Singh (55) yrs at Lamboikhongnangkhang Pal Leirak crossing while he return home along with my mother by foot after buying medicine at Lamboikhongnangkhang, due to rash & negligent driving on the part of the unknown driver of unknown car and fled away toward Iroishemba side. As a result of which, my father received severe injury on his left leg, Chest and head and was evacuated to Raj Hospital for medical treatment.
