Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP (Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Lamphel area. During that one suspected person was detained at RIMS gate, Lamphel for verification. On spot verification, the detainee identified himself as Sorokhaibam Priyochand Singh (39 yrs.) @ Sajao s/o. (L) S. Bihari Singh of Iram Siphai Mamang Leikai, Imphal West District, Manipur.

From his possession, (i) one Samsung Galaxy A23 5G mobile handset along with one Airtel SIM card bearing mobile no. 8132935654 (as disclosed by him) was seized at the spot at 05:00 pm by observing due formalities.

As a follow up action as disclosed by the arrestee, a team of CDO-IW along with the arrestee rushed to the house of the above mentioned Naobi located at Uripok Takhellambam area and successfully detained Naobi from his residence who later on identified himself as Moirangthem Naobi Singh (47 yrs.) s/o.
