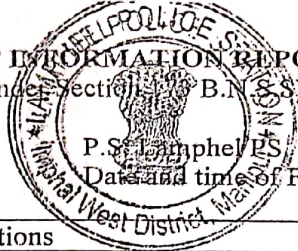

Subject: Complaint regarding a road traffic accident causing grievous hurt to a two-wheeler driver

Sir,

I am writing to bring to your immediate attention a serious road accident that occurred on 27/05/2026 at around 5:00 pm near Pulmocare, Sanakeithel road Lamphel.

The accident involved a two-wheeler TVS Jupiter bearing registration number MN01AR-4397 and a KIA bearing registration number MN01AW-1457.

At the time of the incident, the driver of the TVS Jupiter identified as Rajkumari Renuka Devi who is my younger sister resident of Thangmeiband Lourengpured Leikai, Imphal West was riding towards south (RIMS). The Kia Car which was being driven at a high speed on same direction in a rash and negligence manner by its driver hit the Jupiter hardly from behind.

Due to the severe impact of the hard hit by the KIA car from behind, the rider of the Jupiter was thrown off the vehicle onto the road, sustaining a severe head injury and other multiple injuries. The injured person was immediately rushed to RIMS Hospital. After an emergency medical treatment at RIMS, she was referred to SHIJA Hospital due to serious injury. The driver of Kia Car fled the scene immediately after the accident along with the vehicle.

I request you to kindly register First information Report (FIR) against the driver of Kia car under the relevant section of the law for rash negligent driving causing grievous hurt, and to initiate a thorough investigation into the matter.
