Subject: - Report.

Sir,

I have the honour to state that yesterday, i.e., on 09/05/2026 at around 5:00 PM, I went to Ranju Jewellery Shop located at Pratap Talkies, Paona Bazar, Imphal, to collect one pair of earrings which had been given for polishing 2/3 days earlier. I went there by driving my white-coloured Fronx Delta bearing Registration No. MN01AX-8874.

After reaching Wahengbam Leikai, I parked my vehicle on the Mayai Lambi side near the hump bridge close to Kakhulong and walked towards the said shop after crossing the hump bridge. After collecting my earrings, I left Ranju Jewellery Shop and walked towards Khwairamband Bazar for shopping for some other items. After completing my shopping, I returned towards my vehicle via Wahengbam Leikai bus parking.

After reaching my vehicle and while trying to drive away at around 6:30 pm 2 (two) unknown masked men forcibly entered my vehicle, threatened me by showing a pistol, and snatched my mobile phone, which was kept in switch-off mode. They also blindfolded me and drove away. After driving for some time they stopped the vehicle and left hurriedly after taking away my side bag containing 4 tolas of gold.

Thereafter, I removed the blindfold and found myself near the hill range of Ngariyan Hill. I then switched on my mobile phone, called my wife, and returned home as soon as possible.

It is, therefore, requested that necessary legal action may kindly be taken against the unknown culprits as per law at the earliest.
