I have the honour to report that today, i.e., 25/06/2026, at around 0930 hrs, credible and specific information was received regarding the presence of an active cadre of the banned organization SOREPA (a faction of KYKL), who was involved in extortion activities on behalf of the organization at Umathel Mathak Leikai, Kakching District. On receiving the input, a team of CDO Unit Kakching comprising of Kilo-49, Kilo-74(m) and a Column of 46 AR, under the command of Sub. S. Birla Singh, OC/CDO Kakching, under the supervision of Shri Shankerjit Loitongbam, MPS, Addl. SP(LO), Kakching, and overall supervision of Smt. Priyadarshini Laishram, IPS, Superintendent of Police, Kakching District, rushed to the said area and conducted a search operation in the suspected locations at Umathel Mathak Leikai.

During the search, one suspected individual, matching the input received, was detained from his residence at Umathel Mathak Leikai. On preliminary examination, the detainee identified himself as Shamjetshabam Kokfai Meitei age about 26 yrs S/o. Sh. Jotin Singh of Kakching Khunou Umathel Mathak Leikai, Kakching District. Upon further questioning, he disclosed that he is an active cadre of the banned organization SOREPA (a faction of KYKL). He joined the organization in Sept., 2023 through one Self-styled Army Chief Samu of the said organization and works under his command of the said organization, who is presently in Bangladesh. He further disclosed that he has been actively engaged in collecting extortion money and issuing monetary demands from various individuals and establishments in Imphal West, Imphal East and Bishnupur District on behalf of SOREPA (a faction of KYKL) raising funds to further the activities of the proscribed organization.

From his possession, Samsung S23 Ultra mobile phone bearing IMEI-1: 353835881873840/01 and IMEI-2: 353901651873848/01, along with 2(two) Sims i.e (i) Jio SIM no.7994963433 & (ii) Airtel Sim no. 7085174642 was recovered and seized at 1140 hrs., by observing all legal formalities. The said articles are believed to contain material relevant to the unlawful activities of the organization and were seized after observing all legal formalities. Videography of the seizure was also done at the spot.

Following his admissions, he was arrested at 1135 hrs. by observing all legal formalities as per law.
