Lunkhopao Haokip (59) Yrs Paokhohang Haokip of M. G Avenue Thangak Bazar, IW A/p Saitu Village, Kangpokpi District lodge a written report to OC G-SPM-PS stating that on 20-05-2023 during the period of communal violence in the state, unknown persons willfully vandalized and set fire to my residential houser located at Catholic Veng, Lamlongei, Mantripukhri, Imphal East. During the said incident, floor tiles, marble slabs, false ceiling were destroyed teak wood doors and UPVC windows were stolen and important business and personal document such as Government payment bills, purchase invoice, vouchers, work order, expenditure ledgers, bank transaction details and all my business records related to my contract work business, insurance papers, mutual fund documents, property deeds, education certificates of my family members were all burnt and destroyed. The loss a]was then assessed at ₹ 25,00,000/- On 30th January 2026 I have learnt from reliable sources that unknown miscreants kept trespassing into the premises and caused further extensive damaged by removing and stealing boundary fencing walls and steel gates. Breaking internal portions walls and removing bricks, stealing/damaging sanitary fitting, built-in closet and electrical appliances, fitting, wiring etc. Due to the continued acts a of vandalism, theft and destruction the total loss suffering by me has now escalated to approximately ₹ 1,50,00,000/- (rupees One crore fifty lahks only). The above acts cleanly disclosed the commission of cognizable offences punishable under relevant provisions of the Bhartiya Nyaya Sanhita (BNS) and other applicable laws. Hence the case.

Subject: Complaint for registration of FIR regarding continued vandalism arson, and theft of residential property.

Sir,

I hereby state the above facts for your kind consideration and necessary action. That, I submit this complaint for registration of an FIR against unknown miscreants.

That on 20-05-2023, during the period of communal violence in the State, unknown persons wilfully vandalized and set fire to my residential house located at Catholic Veng, Lamlonggei, Mantripukhri, Imphal East. A complaint in this regard was already lodged at Heingang Police Station.

During the said incident, floor tiles, marble slabs, false ceiling were destroyed; teak wood doors and UPVC windows were stolen; and important business and personal documents such as Government payment bills, purchase invoices, vouchers, work orders, expenditure ledgers, bank transaction details and all my business records related to my contract work business, insurance papers, mutual fund documents, property deeds, educational certificates of my family members were all burnt and destroyed. The loss was then assessed at ₹25,00,000/-.

That after 20-05-2023, the looting and destruction of my said residence continued at different times. On 30th January 2026 I have learnt from reliable sources that unknown miscreants kept trespassing into the premises and caused further extensive damage by removing and stealing boundary fencing walls and steel gates, breaking internal partition walls and removing bricks, stealing /damaging sanitary fittings, built-in closets, and electrical appliances, fittings, wirings etc. Due to the continued acts of vandalism, theft, and destruction, the total loss suffered by me has now escalated to approximately ₹1,50,00,000/- (Rupees One Crore Fifty Lakhs only). The above acts clearly disclose the commission of cognizable offences punishable under relevant provisions of the Bharatiya Nyaya Sanhita (BNS) and other applicable laws.

I therefore humbly request you to kindly register an FIR, to investigate the matter, and take necessary legal action against the unknown offenders as per law.
