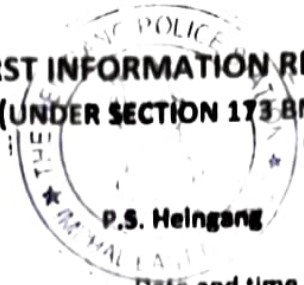

12. **First Information Contents.** Brahmacharimayum Amarjit Sharma, Sub-Inspector of BPR Now attached with CDO-IW lodge a written report to OC HNG-PS stating that today i.e 14/02/2026 at about 08:55 am, a reliable information was received from their own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of PREPAK (Pro) organization (a faction of PREPAK organization), an outlawed banned organization, in and around Khabam Lamkhai area of Imphal East District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at some suspected places near Khabam Lamkhai area. During that one suspected person was detained from a hotel located near Manipur Highway Service Station, Khabam Lamkhai for verification. On spot verification, the detainee identified himself as Sorokhaibam Ranjit Singh (41 yrs.) s/o. S. Achou Singh of Chairel Makha Leikai, Kakching District, Manipur a/p at a rented house located at Khabam Chumbreithong, Imphal East District, Manipur (who later identified himself as the owner/proprietor of the said hotel). During preliminary verification, he disclosed that he is an active member of PREPAK (Pro) organization (a faction of PREPAK organization) and started working for the said organization since the year 2025 through one Shyam @ Sopaingamba (Ph. no. 7085818535) of PREPAK (Pro) organization (in the Finance Section) from Chairel area who is presently staying in Myanmar. He also disclosed that under the instruction of the above mentioned Shyam @ Sopaingamba of PREPAK (Pro) organization, he was involved in extortion activities by receiving extortion money from general public for raising their party fund. He further disclosed that under the instruction of Shyam @ Sopaingamba, he received an extorted amount of a sum of Rs. 10,000/- from unknown persons sent by Shyam @ Sopaingamba in the month of June/July 2025. He further disclosed that today, i.e., 14/02/2026 he was instructed by Shyam @ Sopaingamba to receive an extortion amount of a sum of Rs. 15,000/- from unknown persons sent by Shyam @ Sopaingamba at Nagamapal area. Hence, he was arrested from the spot i.e. from his hotel located near Manipur Highway Service Station, Khabam Lamkhai at 09:55 am by observing formalities. From his possession, (i) one realme C3 mobile handset along with one Jio SIM card bearing mobile no. 9366958859 (as disclosed by him), (ii) one Redmi 13C mobile handset along with one Jio SIM card bearing mobile no. 8575771754 (as disclosed by him) and (iii) one Aadhaar card bearing no. 4555 3992 1769 were seized at the spot at 10:00 am by observing due formalities. From his possession, (i) one realme C3 mobile handset along with one Jio SIM card bearing mobile no. 9366958859 (as disclosed by him), (ii) one Redmi 13C mobile handset along with one Jio SIM card bearing mobile no. 8575771754 (as disclosed by him) and (iii) one Aadhaar card bearing no. 4555 3992 1769 were seized at the spot at 10:00 am by observing due formalities.
