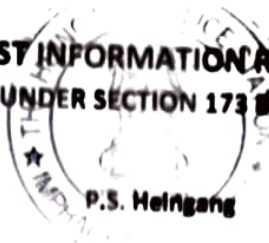

Imocha Singh of Uripok Polem Leikai, Imphal West was riding his scooter Vespa bearing Regd. No. MN06L-2957 from Pangei towards Imphal side, when he was struck by an unknown vehicle which was also coming in same direction at Khomidok in front of Oil Pump, Imphal East and the unknown vehicle immediately fled the spot after committing the crime. As a result, his younger brother sustained injuries on his person and evacuated to hospital for medical treatment. The accident not only causes injuries but also resulted in damage to the vehicle scooter. Hence the case.
