FIR Contents :- One ASI I. Dhanachandra Singh of HNG-PS lodged a written report to OC/HNG-PS stating that today i.e 20/02/2026 at around 9:30 am, frisking and checking was carried out at Khomidok Masjid Maning, IE, area by a team Heingang PS/IE, OC/ HNG-PS and CDO-IE team led by Shri. M. Dimartan Singh, MPS, Dy. SP (Ops), IE under overall supervision of Superintendent of Police, IE. While doing so, a passenger auto RE black in colour, which was coming from Kairang Umang Leikai towards Heikrumakhong Bazar, was seen stopped at a distant place about 50 metres away from us and a person, on seeing security forces, abandoned the auto RE and fled the spot. Our teams immediately rushed to the spot and cordoned the auto RE bearing r/no. AS 01 NC 0846 and detained an individual found beside the auto RE. As the situation drew suspicion, the auto RE was searched for concealment of any illegal articles. During the search, a brown colour packet wrapped with cellotape in a black colour polythene bag was found concealed underneath the driver seat of the auto RE and on opening the packet, 24 (twenty-four) nos. of blue colour plastic packet containing suspected to be WY tablets were found inside the brown colour packet. On further enquiry, the individual identified himself as one Mohammad Warish Khan (28 yrs) s/o (L) Mohammad Nurjaman of Khomidok Masjid Maning, Imphal East-795114 and stated that he is the owner of the auto RE bearing r/no. AS 01 NC 0846. The owner further disclosed that the brown colour packet wrapped with cellotape containing suspected to be WY tablets belonged to him. On the other hand, a large mob started to gather causing hindrance to further course of action so Mohammad Warish Khan and the auto RE along with brown colour packet wrapped with cellotape containing WY tablets were then taken to Heingang Police Station and reached the station at around 11:05 am. On reaching police station, the 24 (twenty-four) nos. of blue colour plastic packet containing WY tablets were found to weigh 550 gm including the packet and black colour polythene bag on conventional weighing. On preliminary examination, the detainee namely Mohammad Warish Khan admitted that the WY tablets were procured from one supplier (name not known) from Chandel Bazar about a few months back for sale to other customers in Imphal areas. Accordingly, the following articles i.e. (i) one brown colour packet wrapped with cellotape containing suspected to be WY tablets in 24 (twenty-four) blue colour small plastic packets weighing 550 gm including the packet and black colour polythene bag, (ii) one auto RE black in colour bearing r/no. AS 01 NC 0846, (iii) one Redmi light green colour mobile phone bearing model no. - 24115RA8EI and mobile no. - 9366876205 and (iv) one Aadhaar card bearing no. - 211884962012 were seized from his possession at Heingang Police Station at 01:10 pm and he was arrested at 01:20 pm by observing necessary formalities. The arrestee along with the seized articles are being handed over to you for taking up further necessary legal action. Hence the case.
