Complainant namely SI. Nareshkumar Moirangthem, 8th IRB, Now attached with CDO/IE unit lodged a written report to OC/HNG PS stating that 25th February, 2026 at about 3:00 p.m. received a reliable information from our own source corroborated with the intelligence of 33 AR about the presence of an active member of the outfit RPF/PLA at Koirengei area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 4:00 p.m.

In that, one suspected person was detain for verification and checking at Koirengei Manung Laikon Leirak, Imphal East District. On checking the detainee body, two nos. of mobile phones were found and recovered from his possession. On verification the detainee identified himself as one, Moirangthem Jenyson Singh @ Ahenba @ Naobi (26 years) S/o M. James Singh of Wangjing Sorokhaiba m Leikai, Thoubal District. A/p – Koirengei Manung Laikon Leirak, Heingang PS, Imphal East District. On further verification the detainee stated that he is an active member of the outfit RPF/PLA, who joined through one Mr. Wang of RPF/PLA in the month of August, 2023 and got basic military training for 15 days at Wangjing, Thoubal District under the command of one Mr. Wang of RPF/PLA. On further verification, the detainee stated that he is presently working under the command of one Mr. Lamyamba of RPF/PLA. The detainee further stated that, on the advice of the said Mr. Lamyamba of RPF/PLA, he had extorted a huge amount of money from the general public, transport offices and hardware stores for raising their party fund.

So, the detainee was arrested from the spot i.e. Koirengei Manung Laikon Leirak, Imphal East District at 4:37 p.m. and seized (i) one mobile phone (Redmi 13C 5G) bearing IMEI no. 867510070413091/78 & 867510070413109/78 along with one Airtel SIM card having phone no. 7628079249 and (ii) One mobile phone (Redmi 13 5G) bearing IMEI no. 867692072819689 & 867692072819697 along with one Airtel SIM card having phone no. 8974577051 at the spot i.e. Koirengei Manung Laikon Leirak, Heingnag Police Station, Imphal East District at 4:40 p.m. observing due formalities.

On further verification, it came to learnt that some banner of their outfit RPF/PLA were kept concealed at the place he is presently residing i.e. Koirengei Manung Laikon Leirak, Imphal East District. Immediately, our team along with the arrestee, rushed to the said place i.e. Koirengei Manung Laikon Leirak, Imphal East and on the instance and pointing of the arrestee, three nos. of Banner of RPF/PLA for the Foundation Day of their outfit were seized from a drawer of the house where he is presently residing i.e. Koirengei Manung Laikon Leirak, Imphal East District at 6:38 p.m. by observing due formalities.
