The said ^{truck} was driven by another employee of the same company by the name Gopal Kavar (28) yrs S/o Ranjit Kavar of Tispari Kanglatombi, PS- Sekmai, Imphal West – 795136. As a result, Indra Prasad Adhikari sustained serious injury on his person and evacuated to CMC Hospital, Koirengei for medical treatment but the Medical Officer of the Hospital declared him brought dead.
