12. First Information Contents. :- Brief of the case

Complainant namely (Shamjetsabam Sarjubala Devi) W/Inspector of CDO-IW, lodge a written report to OC/HNG-PS stating that yesterday i.e. 28/02/2026 at about 11:30 am, a reliable information was received that one Shamjetsabam Sanjoy Singh of Nongpok Lourembam, Thoubal District, Manipur (Ph. No. 8787630886) has been abducted by some unknown miscreants and is being detained somewhere at Mantripukhri Chumbrei Thong area. Based on the information which is further corroborated from the information input provided by 165 TA and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and Shri K. Dineshkumar Singh, MPS, Dy. SP(CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation in the said area. During the operation, five individuals were found in one of the rooms of a Godown located at Mantripukhri Chumbrei Thong. The said individuals, on spot verification, identified themselves as (i) Langpoklakpam Moramba Meitei (26 yrs) @ Tondon S/o. (L) L. Ranjtkumar Singh of Keishamthong Hodam Leirak, Imphal West District, Manipur, (ii) Khaidem Suraj Singh (22 yrs) @ Goro S/o. Kh. Jiten Singh of Keibung Oinam Leikai, Imphal West District, Manipur, (iii) Thongbam Anilkumar Singh (25 yrs) @ Hero S/o. Th. Aniton Singh of Keibul Makha Leikai, Bishnupur District, Manipur, (iv) Konsam Sunil Singh (46 yrs) S/o. K. Mani Singh of Yairipok Kekru Makha Leikai, Thoubal District, Manipur and (v) Shamjetsabam Sanjoy Singh (55 yrs) S/o. (L) Sh. Lala Singh of Nongpok Lourembam, Thoubal District, Manipur. Among the five, one was Shamjetsabam Sanjoy Singh, the abducted person as per the intelligence input. Another person namely Thongbam Anilkumar Singh was found badly assaulted and injured. A detailed examination of all the five individuals reveals that Thongbam Anilkumar Singh, Konsam Sunil Singh and Shamjetsabam Sanjoy Singh were kidnapped by Langpoklakpam Moramba Meitei and Khaidem Suraj Singh along with their associates today i.e., 28/02/2026 from Thanga area for ransom. Hence, the three abducted persons were successfully rescued from the spot. The rescued persons disclosed that two mobile handsets which were belonged to Thongbam Anilkumar Singh and Konsam Sunil Singh were forcefully taken away by Langpoklakpam Moramba Meitei and his associates. On further verification, Langpoklakpam Moramba Meitei disclosed that today i.e., 28/02/2026, he along with his associates namely (i) one Herachandra, (ii) one Lokendrajit, (iii) one Akash, (iv) one Araba and (v) Khaidem Suraj Singh @ Goro (the above mentioned) abducted the above mentioned three persons along with one Hyundai Santro car silver in colour (used by the three persons) from Thanga area for ransom by using one Maruti 800 car white in colour and one Maruti Swift car silver in colour and later on, the abducted three persons along with their Hyundai Santro car silver in colour were brought to the said godown located at Mantripukhri Chumbrei Thong and the abducted persons were kept in wrongful confinement at the said godown and assaulted one of the abducted persons. Khaidem Suraj Singh @ Goro also disclosed that today i.e., 28/02/2026, he along with his associate one Araba went to Thanga area by using one Maruti 800 car white in colour and they abducted the above mentioned three persons and proceeded to the said godown carrying one of the abducted persons in their car. Langpoklakpam Moramba Meitei further disclosed that his other associates went to Taothong area for further kidnapping two non-locals using the above mentioned two cars i.e., one Maruti 800 car white in colour bearing registration no. MN01X 3128 and one Maruti Swift car silver in colour bearing registration no. MN01AK 2066. He also disclosed that earlier, he along with his associates namely (i) Lokendrajit (ii) Akash (iii) Herachandra and (iv) one Biken from Babupara area had

abducted the above mentioned Thongbam Anilkumar Singh from Moirang Collage Gate on 21/02/2026 by using one Beat Car brought by Biken and kept Thongbam Anilkumar Singh in wrongful confinement at two different locations (at a house located at Kongba area arranged by Biken and another at the house of one Debeshwor located at Patsoi Part-II area). The above mentioned Hyundai Santro car silver in colour bearing registration no. MN04P 1847 along with its key which was belonged to the above mentioned abducted person namely Shamjetsabam Sanjoy Singh was recovered at the said godown as pointed out by him. So, the two accused namely Khaidem Suraj Singh and Langpoklakpam Moramba Meitei were arrested from the spot i.e. at the Godown located at Mantripukhri Chumbrei Thong at 12:49 pm and 12:51 pm respectively by observing formalities. From the possession of Khaidem Suraj Singh : (i) one Samsung Galaxy A04e mobile handset along with one Airtel SIM card bearing mobile no. 9233172355 (as disclosed by him), (ii) one Aadhaar card bearing no. 3311 9354 3671 card bearing mobile no. 9233172355 (as disclosed by him), (iii) one driving licence bearing no. MN0120240001501 were seized at the spot at 12:56 pm by observing formalities. From the possession of Langpoklakpam Moramba Meitei : (i) one iPhone 14 Plus mobile handset along with one Jio SIM card bearing mobile no. 8131977668 (as disclosed by him) and (ii) one Aadhaar card bearing no. 2195 5086 0840 were seized at the spot at 12:57 pm by observing formalities. Immediately, as a follow up as per the disclosure of the arrestee and on receiving a reliable information regarding the presence of the above mentioned car i.e., one Maruti Swift car silver in colour bearing registration no. MN01AK 2066 at Chingmeirong area, the said CDO-IW team rushed to Chingmeirong area and detained the said car along with four individuals at Chingmeirong Maning Leikai who later identified themselves as (i) Debeshwor Irom (39 yrs) S/o. Irom Jugol Singh of Patsoi Part-II Mayal Leikai, Imphal West District, Manipur, (ii) Nahakpam Lokendrajit Singh (25 yrs) S/o. N. Jugeshwor Singh of Achanbigel Awang Leikai, Imphal East District, Manipur, (iii) Thoudam Herachandra Singh (27 yrs) @ Hera S/o. Th. Inakhunba Singh of Heingang Awang Leikai, Imphal East District, Manipur and (iv) Chungkham Jiban Singh (37 yrs) S/o. Ch. Amumcha Singh of Mayang Imphal Chabung Company Mayal Leikai, Imphal West District, Manipur (driver of the said car). On checking the said car, two mobile handsets were recovered which were later found to be the mobile handsets of the abducted persons. On spot verification, Debeshwor Irom disclosed that he was involved in abduction activities since he was involved in wrongful confinement of the above mentioned abducted person namely Thongbam Anilkumar Singh at his residence some days back and today i.e., 28/02/2026, he along with the above detainees went to Taothong area to kidnap two non-locals. Further, Chungkham Jiban Singh disclosed that he was involved in abduction activities as he provided his Maruti Swift car silver in colour bearing registration no. MN01AK 2066 to above mentioned arrestee Langpoklakpam Moramba Meitei to be used in the abduction of the above mentioned abducted persons and today i.e., 28/02/2026, he along with the above mentioned detainees went to Taothong area to kidnap two non-locals. Nahakpam Lokendrajit Singh and Thoudam Herachandra Singh disclosed that earlier, they were involved in the abduction of the above mentioned Thongbam Anilkumar Singh on 21/02/2026 from Moirang area for ransom and also involved in the abduction of above mentioned three abducted persons today i.e., 28/02/2026 from Thanga area for ransom. The detainees disclosed that their associates namely one Araba and one Akash who were involved in the abduction of the above mentioned three abducted persons had proceeded towards the godown located at Mantripukhri Chumbrei Thong using the above mentioned Maruti 800 car white in colour bearing registration no. MN01X 3128. Hence, (i) Debeshwor Irom, (ii) Nahakpam Lokendrajit Singh, (iii) Thoudam Herachandra Singh and (iv) Chungkham Jiban Singh were arrested from the spot i.e. at Chingmeirong Maning Leikai at 01:10 pm, 01:12 pm, 01:14 pm and 01:16 pm respectively by observing formalities. From the possession of Debeshwor Irom : (i) one realme C35 mobile handset along with one Airtel SIM card bearing mobile no. 9856134089 (as disclosed by him) and (ii) one Aadhaar card bearing no. 5791 2680 9441 were seized at the spot at 01:20 pm by observing formalities. From the possession of Nahakpam Lokendrajit Singh : (i) one Redmi 13 5G mobile handset along with two Airtel SIM cards bearing mobile nos. (a) 8119962760 and (b) 8118939794 (as disclosed by him) and (ii) one Aadhaar card bearing no. 6200 2618 6925 were seized at the spot at 01:23 pm by observing formalities. From the possession of Thoudam Herachandra Singh : (i) one OnePlus Nord CE5 mobile handset along with two SIM cards i.e., (a) one Jio SIM card bearing mobile no. 8787314615 (as disclosed by him) and (b) one Airtel SIM card bearing mobile no. 8132855689 (as disclosed by him) was seized at the spot at 01:25 pm by observing formalities. From the possession of Chungkham Jiban Singh : (i) one Redmi Note 12 Pro 5G mobile handset along with two SIM cards i.e., (a) one Jio SIM card bearing mobile no. 8729946153 (as disclosed by him) and (b) one Vodafone SIM card bearing mobile no. 7085350618 (as disclosed by him) and (ii) one Maruti Swift car silver in colour bearing registration no. MN01AK 2066 along with its key were seized at the spot at 01:28 pm by observing formalities. Immediately, the said CDO-IW team rushed towards Mantripukhri Chumbrei Thong area and successfully detained (i) Langpoklakpam Araba Meitei (34 yrs) @ Bungcha S/o. (L) L. Ranjitkumar Singh of Keishamthong Hodam Leirak, Imphal West District, Manipur and (ii) Wahengbam Akash Singh (27 yrs) S/o. W. Ajit Singh of Kwakeithel Moirang Pural Leikai, Imphal West District, Manipur along with the Maruti 800 car white in colour bearing registration no. MN01X 3128 near the entrance of the said godown located at Mantripukhri Chumbrei Thong. On spot verification they disclosed that they were involved in the abduction of the above mentioned three abducted persons today i.e., 28/02/2026 from Thanga area for ransom. Hence, (i) Langpoklakpam Araba Meitei and (ii) Wahengbam Akash Singh were arrested from the spot i.e. near the entrance of the godown located at Mantripukhri Chumbrei Thong at 01:46 pm and 01:49 pm respectively by observing formalities. From the possession of Langpoklakpam Araba Meitei: (i) one vivo Y28 5G mobile handset along with two SIM cards i.e., (a) one Airtel SIM card bearing mobile no. 8258992609 (as disclosed by him) and (b) one Jio SIM card bearing mobile no. 7005272910 (as disclosed by him), (ii) one brown wallet containing a sum of Rs. 110/- (Rupees one hundred and ten only) and one Aadhaar card bearing no. 5655 7154 4951 and (iii) one Maruti 800 car white in colour bearing registration no. MN01X 3128 along with its key were seized at the spot at 01:52 pm by observing formalities. From the possession of Wahengbam Akash Singh: (i) one Redmi Note 8 Pro mobile handset along

with two SIM cards i.e., (a) one Vodafone SIM card bearing mobile no. 8256944084 (as disclosed by him) and (b) one Jio SIM card bearing mobile no. 7005549660 (as disclosed by him) and (ii) one brown wallet containing a sum of Rs. 1000/- (Rupees one thousand only) and one Aadhaar card bearing no. 5490 1168 3740 were seized at the spot at 01:55 pm by observing formalities. Hence, the arrested persons, the above seized articles, the rescued persons along with their recovered items (two mobile handsets and one Hyundai Santro car silver in colour bearing registration no. MN04P 1847 along with its key) are handed over to you for taking further necessary legal action against them.

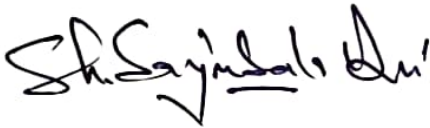

A detailed examination of all the five individuals reveals that Thongbam Anilkumar Singh, Konsam Sunil Singh and Shamjetsabam Sanjoy Singh were kidnapped by Langpoklakpam Moramba Meitei and Khaidem Suraj Singh along with their associates today i.e., 28/02/2026 from Thanga area for ransom. Hence, the three abducted persons were successfully rescued from the spot. The rescued persons disclosed that two mobile handsets which were belonged to Thongbam Anilkumar Singh and Konsam Sunil Singh were forcefully taken away by Langpoklakpam Moramba Meitei and his associates.

On further verification, Langpoklakpam Moramba Meitei disclosed that today i.e., 28/02/2026, he along with his associates namely (i) one Herachandra, (ii) one Lokendrajit, (iii) one Akash, (iv) one Araba and (v) Khaidem Suraj Singh @ Goro (the above mentioned) abducted the above mentioned three persons along with one Hyundai Santro car silver in colour (used by the three persons) from Thanga area for ransom by using one Maruti 800 car white in colour and one Maruti Swift car silver in colour and later on, the abducted three persons along with their Hyundai Santro car silver in colour were brought to the said godown located at Mantripukhri Chumbrei Thong and the abducted persons were kept in wrongful confinement at the said godown and assaulted one of the abducted persons.

Khaidem Suraj Singh @ Goro also disclosed that today i.e., 28/02/2026, he along with his associate one Araba went to Thanga area by using one Maruti 800 car white in colour and they abducted the above mentioned three persons and proceeded to the said godown carrying one of the abducted persons in their car.

Langpoklakpam Moramba Meitei further disclosed that his other associates went to Taothong area for further kidnapping two non-locals using the above mentioned two cars i.e., one Maruti 800 car white in colour bearing registration no. MN01X 3128 and one Maruti Swift car silver in colour bearing registration no. MN01AK 2066. He also disclosed that earlier, he along with his associates namely (i) Lokendrajit (ii) Akash (iii) Herachandra and (iv) one Biken from Babupara area had abducted the above mentioned Thongbam Anilkumar Singh from Moirang Collage Gate on 21/02/2026 by using one Beat Car brought by Biken and kept Thongbam Anilkumar Singh in wrongful confinement at two different locations (at a house located at Kongba area arranged by Biken and another at the house of one Debeshwor located at Patsoi Part-II area).

The above mentioned Hyundai Santro car silver in colour bearing registration no. MN04P 1847 along with its key which was belonged to the above mentioned abducted person namely Shamjetsabam Sanjoy Singh was recovered at the said godown as pointed out by him.

So, the two accused namely Khaidem Suraj Singh and Langpoklakpam Moramba Meitei were arrested from the spot i.e. at the Godown located at Mantripukhri Chumbrei Thong at 12:49 pm and 12:51 pm respectively by observing formalities.

From the possession of Khaidem Suraj Singh : (i) one Samsung Galaxy A04e mobile handset along with one Airtel SIM card bearing mobile no. 9233172355 (as disclosed by him), (ii) one Aadhaar card bearing no. 3311 9354 3671 and (iii) one driving licence bearing no. MN0120240001501 were seized at the spot at 12:56 pm by observing formalities.



From the possession of Langpoklakpam Moramba Meitei : (i) one iPhone 14 Plus mobile handset along with one Jio SIM card bearing mobile no. 8131977668 (as disclosed by him) and (ii) one Aadhaar card bearing no. 2195 5086 0840 were seized at the spot at 12:57 pm by observing formalities.

Immediately, as a follow up as per the disclosure of the arrestee and on receiving a reliable information regarding the presence of the above mentioned car i.e., one Maruti Swift car silver in colour bearing registration no. MN01AK 2066 at Chingmeirong area, the said CDO-IW team rushed to Chingmeirong area and detained the said car along with four individuals at Chingmeirong Maning Leikai who later identified themselves as (i) Debeshwor Irom (39 yrs) S/o. Irom Jugol Singh of Patsoi Part-II Mayai Leikai, Imphal West District, Manipur, (ii) Nahakpam Lokendrajit Singh (25 yrs) S/o. N. Jugeshwor Singh of Achanbigei Awang Leikai, Imphal East District, Manipur, (iii) Thoudam Herachandra Singh (27 yrs) @ Hera S/o. Th. Inakhunba Singh of Heingang Awang Leikai, Imphal East District, Manipur and (iv) Chungkham Jiban Singh (37 yrs) S/o. Ch. Amumcha Singh of Mayang Imphal Chabung Company Mayai Leikai, Imphal West District, Manipur (driver of the said car). On checking the said car, two mobile handsets were recovered which were later found to be the mobile handsets of the abducted persons.

On spot verification, Debeshwor Irom disclosed that he was involved in abduction activities since he was involved in wrongful confinement of the above mentioned abducted person namely Thongbam Anilkumar Singh at his residence some days back and today i.e., 28/02/2026, he along with the above detainees went to Taothong area to kidnap two non-locals.

Further, Chungkham Jiban Singh disclosed that he was involved in abduction activities as he provided his Maruti Swift car silver in colour bearing registration no. MN01AK 2066 to above mentioned arrestee Langpoklakpam Moramba Meitei to be used in the abduction of the above mentioned abducted persons and today i.e., 28/02/2026, he along with the above mentioned detainees went to Taothong area to kidnap two non-locals.

Nahakpam Lokendrajit Singh and Thoudam Herachandra Singh disclosed that earlier, they were involved in the abduction of the above mentioned Thongbam Anilkumar Singh on 21/02/2026 from Moirang area for ransom and also involved in the abduction of above mentioned three abducted persons today i.e., 28/02/2026 from Thanga area for ransom.

The detainees disclosed that their associates namely one Araba and one Akash who were involved in the abduction of the above mentioned three abducted persons had proceeded towards the godown located at Mantripukhri Chumbrei Thong using the above mentioned Maruti 800 car white in colour bearing registration no. MN01X 3128.

Hence, (i) Debeshwor Irom, (ii) Nahakpam Lokendrajit Singh, (iii) Thoudam Herachandra Singh and (iv) Chungkham Jiban Singh were arrested from the spot i.e. at Chingmeirong Maning Leikai at 01:10 pm, 01:12 pm, 01:14 pm and 01:16 pm respectively by observing formalities.

From the possession of Debeshwor Irom : (i) one realme C35 mobile handset along with one Airtel SIM card bearing mobile no. 9856134089 (as disclosed by him) and (ii) one Aadhaar card bearing no. 5791 2680 9441 were seized at the spot at 01:20 pm by observing formalities.

From the possession of Nahakpam Lokendrajit Singh : (i) one Redmi 13 5G mobile handset along with two Airtel SIM cards bearing mobile nos. (a) 8119962760 and (b) 8118939794 (as disclosed by him) and (ii) one Aadhaar card bearing no. 6200 2618 6925 were seized at the spot at 01:23 pm by observing formalities.

From the possession of Thoudam Herachandra Singh : (i) one OnePlus Nord CE5 mobile handset along with two SIM cards i.e., (a) one Jio SIM card bearing mobile no. 8787314615 (as disclosed by him) and (b) one Airtel SIM card bearing mobile no. 8132855689 (as disclosed by him) was seized at the spot at 01:25 pm by observing formalities.

From the possession of Chungkham Jiban Singh : (i) one Redmi Note 12 Pro 5G mobile handset along with two SIM cards i.e., (a) one Jio SIM card bearing mobile no. 8729946153 (as disclosed by him) and (b) one Vodafone SIM card bearing mobile no. 7085350618 (as disclosed by him) and (ii) one Maruti Swift car silver in colour bearing registration no. MN01AK 2066 along with its key were seized at the spot at 01:28 pm by observing formalities.

Immediately, the said CDO-IW team rushed towards Mantripukhri Chumbrei Thong area and successfully detained (i) Langpoklakpam Araba Meitei (34 yrs) @ Bungcha S/o. (L) L. Ranjitkumar Singh of Keishamthong Hodam Leirak, Imphal West District, Manipur and (ii) Wahengbam Akash Singh (27 yrs) S/o. W. Ajit Singh of Kwakeithel Moirang Pural Leikai, Imphal West District, Manipur along with the Maruti 800 car white in colour bearing registration no. MN01X 3128 near the entrance of the said godown located at Mantripukhri Chumbrei Thong. On spot verification they disclosed that they were involved in the abduction of the above mentioned three abducted persons today i.e., 28/02/2026 from Thanga area for ransom.

Hence, (i) Langpoklakpam Araba Meitei and (ii) Wahengbam Akash Singh were arrested from the spot i.e. near the entrance of the godown located at Mantripukhri Chumbrei Thong at 01:46 pm and 01:49 pm respectively by observing formalities.

From the possession of Langpoklakpam Araba Meitei : (i) one vivo Y28 5G mobile handset along with two SIM cards i.e., (a) one Airtel SIM card bearing mobile no. 8258992609 (as disclosed by him) and

(b) one Jio SIM card bearing mobile no. 7005272910 (as disclosed by him), (ii) one brown wallet containing a sum of Rs. 110/- (Rupees one hundred and ten only) and one Aadhaar card bearing no. 5655 7154 4951 and (iii) one Maruti 800 car white in colour bearing registration no. MN01X 3128 along with its key were seized at the spot at 01:52 pm by observing formalities.

From the possession of Wahengbam Akash Singh: (i) one Redmi Note 8 Pro mobile handset along with two SIM cards i.e., (a) one Vodafone SIM card bearing mobile no. 8256944084 (as disclosed by him) and (b) one Jio SIM card bearing mobile no. 7005549660 (as disclosed by him) and (ii) one brown wallet containing a sum of Rs. 1000/- (Rupees one thousand only) and one Aadhaar card bearing no. 5490 1168 3740 were seized at the spot at 01:55 pm by observing formalities.

Hence, the arrested persons, the above seized articles, the rescued persons along with their recovered items (two mobile handsets and one Hyundai Santro car silver in colour bearing registration no. MN04P 1847 along with its key) are handed over to you for taking further necessary legal action against them.
