1. An Input was received regarding the likely movement of a suspected cadre from Kakching to Pallel. Accordingly, 02 Mobile Check Posts ex 10 Assam Rifles were established near Forest Gate (approx 400m) and at Molnoi Area. On 17 Jul 2026 at around 1428 hrs, one male, namely Chirom Modai Meitei, aged 43 years, was intercepted and apprehended under suspicion by the MCP placed deployed near Forest Gate, Pallel (Kakching District) under suspicion. During preliminary questioning, the individual disclosed his association with the People's Liberation Army UG Group (PLA).

2. During sustained interrogation, the individual further disclosed that he had joined the People's Liberation Army in July 2023. Initially he was entrusted with providing administrative and logistical support to the UG Cadres (PLA), including arranging food, essential supplies and other routine assistance. Subsequently, he became actively associated with a 15 member UG Group (PLA) led by SS Sgt Maj Open and had participated with the said team during 2023 Manipur ethnic violence. Additionally, the individual also stated that he visited the training camp at Komnao village (Kakching District) two times where he received basic training in weapon handling by the UG Cadres (PLA). The individual was also tasked to travel to areas including Sugnu, Tangjeng and Chairael along with the above mentioned team for carrying out activities in furtherance of the objectives of the proscribed outfit.

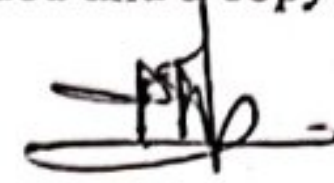
