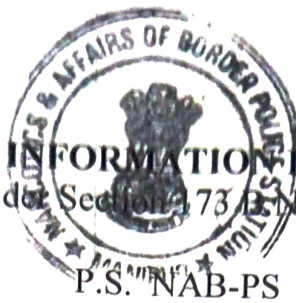

Subject: Report.

Sir,

I have the honour to state that, today i.e., 12/06/2026 at about 04.30 pm, when I was at NAB-PS, Manipur one of my source man informed me that, one person namely Sukham Rozer Singh 25 yrs s/o S. Joykumar Singh of Sagolband Sayang Pukhri Mapal, Imphal West District, Manipur is going to transport Cocaine near Arabam Nityananda, RIMS Road, Imphal West. The said information was reduced in writing and placed before the Superintendent of Police/NAB, Manipur. Then, I along with a team of NAB-PS, Manipur and all the necessary equipments was constituted for execution of the secret information.

The detailed team moved towards Arabam Nityananda, RIMS road, Imphal West in the departmental vehicle bearing No. MN01G 0361 along with necessary equipment and documents. While reaching Arabam Nityananda, RIMS Road, Imphal West, the police team of NAB-PS, Manipur take position for looking the said person. As identified by the source man, the said person namely Sukham Rozer Singh was seen coming from Nagamapal by riding a scooty bearing Regd. No MN06S B6852 red in colour towards Arabam Nityananda, Imphal West District, Manipur. Accordingly, the deployed team in the spot stopped him at the junction of Uripok Tourangabam Leikai Road and Nagamapal RIMS Road for verification and checking. He tried to escape from the police arrest but the deployed team of NAB-PS, Manipur with swift action he was detained at the spot after identifying ourselves as the police officer and personnel of NAB-PS, Manipur. On asking, the detainee told that he has 3 (three) small white plastic packets of suspected cocaine inside his right pocket of pant. At the same time I requested nearby civilians to witness the legal procedures of search, seizure and arrest but no one agreed to witness the same. So, two personnel of my police team namely HC L. Amarjit Singh 38 yrs s/o L. Joykumar Singh of Khurai Chaithabi Leirak, Imphal East District, Manipur and Wakambam Rocky Singh 31 yrs s/o W. Nabachandra Singh of Laipham Khunou Makha Leikai, Imphal East, Manipur a/p Khuman Lampak Hockey Stadium voluntarily agreed to witness the same.

I briefed about the provisions of section 50 NDPS Act, 1985 in Manipuri language to the detainee and was informed that he has legal right under section 50 NDPS Act to be searched before Magistrate/Gazetted Officer or Civil/Independent witnesses, if he so desire. A notice u/s 50 NDPS Act was also served to him in which he told that, he opted to be searched before civil witnesses. In presence of the witnesses, the detainee produced 3 (three) small white plastic packets of suspected cocaine inside his right pocket of pant and further he revealed that the same cocaine were took from one person namely Mutum Giriraj @ Pakpa of Sagolband Meino Leirak Imphal West, Manipur. With the telephonic conversation between the detainee and Mutum Giriraj @ Pakpa, it is learnt that he is at his home. As there is high chance of escape of the culprit, I along with the police team and women police of NAB-PS, Manipur and the detainee proceeds towards the residence of Mutum Giriraj @ Pakpa of Sagolband Meino Leirak Imphal West, Manipur and he was found at his home. On asking he informed the police team that, he has kept 3 (three) packets of suspected cocaine in an iron almirah inside a pocket of his jacket inside his bed room and he voluntarily offered to produce the same. He was allowed to do the same and accordingly took out the 3 (three) packets of suspected cocaine which he had kept in his iron almirah.

At the meantime, a requisition was submitted to Scientific Officer, Mobile Forensic Unit, Lamphel, Imphal West for deputing a team of Mobile Forensic Unit, Imphal West District, Lamphel. As it was almost dusk-dark and raining heavily Smt. Ningombam Sashibala Devi, Scientific Assistant requested to bring the seized cocaine and the detainee at the office of Mobile Forensic Unit, Imphal West District, Lamphel through mobile phone (9862253280) for conducting legal procedures. I briefed about the provisions of section 50 NDPS Act, 1985 in Manipuri language to the detainee and was informed that he has legal rights under section 50 NDPS Act to be searched before Magistrate/Gazetted Officer or Civil/Independent witnesses, if he so desire. A notice u/s 50 NDPS Act was also served to him in which he told that, he opted to be searched before civil witnesses. I requested nearby civilian to witness beyond his family members but no one agreed to witness the same. So, the same aforementioned witnesses voluntarily agreed to witness the same too.

In presence of the witnesses, the detainee namely Mutum Giriraj @ Pakpa voluntarily produced a white transparent plastic packet containing 3 (three) small packets white in colour suspected to be cocaine. As requested by Scientific Assistant the team brought the seized cocaine and 2 (two) detainee at the office of Mobile Forensic Unit, Imphal West District, Lamphel. On reaching, the team of Mobile Forensic Unit, Imphal West District and the police team started conducting legal procedure at the spot. On verification, the 2 (two) detainee identified themselves as 1) Sukham Rozer Singh 25 yrs s/o S. Joykumar Singh of Sagolband Sayang Pukhri Mapal, Imphal West District, Manipur and 2) Mutum Giriraj @ Pakpa 29 yrs s/o (L) Jiban @ Jibon of Sagolband Meino Leirak Imphal West, Manipur.

Accordingly, the Mobile Forensic Unit, Imphal West District team marked the 3 (three) small white plastic packets of suspected cocaine detected from Sukham Rozer Singh marked as "A1", "A2" and "A3" for identification. All the substances in the three packets are identical in colour and texture, the Scientific Assistant took a small pinch from "A1" for field testing by using the field testing kits and gave positive response of Cocaine.

Further, a white transparent plastic packet containing 3 (three) small packets white in colour suspected to be cocaine was marked "B" for identification. On opening "B" found 3 (three) small packets white in colour suspected to be cocaine which are coated by transparent plastic. The 3 (three) small packets were marked as "B1", "B2" and "B3" for identification and similarly as all the substances in the three packets are identical in size, colour and texture, the Scientific Assistant took a small pinch from "B1" for field testing by using the field testing kits and gave positive response of Cocaine. The packets marked "A1", "A2" and "A3" were put in a transparent polythene and marked "A". The packets marked "B1", "B2" and "B3" were put in its original polythene packet i.e white transparent plastic packet and marked "B". On weighing, "A" weighed 4.510 grams of cocaine including the weight of the plastic packet and "B" weighed 18.642 grams of cocaine including the weight of the plastic packet. "A" and "B" are put in 2 (two) separate yellow paper envelopes marked as "C" and "D" which are properly packed and sealed with wax by using the facsimile of OC NAB PS Manipur.

In presence of the witnesses, one yellow paper envelope marked as "C" which is properly packed and sealed with wax by using the facsimile of OC NAB PS Manipur containing one transparent polythene containing 4.510 grams of cocaine including the weight of the plastic packet were seized from the possession of Sukham Rozer Singh 25 yrs s/o S. Joykumar Singh of Sagolband Sayang Pukhri Mapal, Imphal West District, Manipur at the spot on the same day at 8.25 pm by preparing a weighing and seizure memo.

Further, One mobile phone ONE PLUS NORD CE 2 bearing mobile No. 7300652051, One Hero Duet bearing Regd. No MN06S B6852 red in colour was also seized on production by Sukham Rozer Singh 25 yrs s/o S. Joykumar Singh of Sagolband Sayang

Pukhri Mapal, Imphal West District, Manipur at the spot on the same day at 08.28 pm by preparing a seizure memo.

In presence of the witnesses, one yellow paper envelope marked as "D" which is properly packed and sealed with wax by using the facsimile of OC NAB PS Manipur containing one white transparent plastic packet containing 18.642 grams of cocaine including the weight of the plastic packet were seized from the possession of Mutum Giriraj @ Pakpa 29 yrs s/o (L) Jiban @ Jibon of Sagolband Meino Leirak Imphal West, Manipur at the spot on the same day at 8.30 pm by preparing a weighing and seizure memo.

Further, One mobile phone I Phone 15 Pro Silver Colour bearing mobile No. 8787458688 was also seized on production by Mutum Giriraj @ Pakpa 29 yrs s/o (L) Jiban @ Jibon of Sagolband Meino Leirak Imphal West, Manipur at the spot on the same day at 08.32 pm by preparing a seizure memo.

Accordingly, 1) Sukham Rozer Singh 25 yrs s/o S. Joykumar Singh of Sagolband Sayang Pukhri Mapal, Imphal West District, Manipur and 2) Mutum Giriraj @ Pakpa 29 yrs s/o (L) Jiban @ Jibon of Sagolband Meino Leirak Imphal West, Manipur were arrested at the spot on the same day at 8.35 pm and 8.40 pm respectively.

The whole process of seizure and arrest was video graphed in my eSakshya account. I gave intimation about the arrest of the accused persons namely 1) Sukham Rozer Singh 25 yrs s/o S. Joykumar Singh of Sagolband Sayang Pukhri Mapal, Imphal West District, Manipur and 2) Mutum Giriraj @ Pakpa 29 yrs s/o (L) Jiban @ Jibon of Sagolband Meino Leirak Imphal West, Manipur to his father and his wife respectively and intimated the accused person about the ground of their arrest. I took the signatures of the arrested accused persons and witnesses in the parent exhibit, weighing and seizure memo, seizure memo and arrest memo and I also put my signatures on the same.

Hence, the arrested accused persons along with the seized items are handed over to you for taking necessary actions.

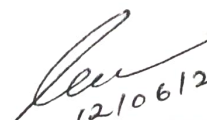
