I have the honor to submit you the report that, based on credible intelligence input received from 237 Intelligence and Field Security Unit, further corroborated through own ground sources, regarding likely movement of an Anti National Element in general area of Khangtung near IMB opposite BP 67 (06 Kms of Changpol), an operation was launched by coln ex 45 AR (Str-01/01/10) along with Manipur Police on 17 July 2026 at 1100hr.

2. Acting swiftly on the specific intelligence, the coln moved to the suspected area effectively dominated the likely route of movement. During the operation, one individual in vicinity of the IMB and matching the input was intercepted and apprehended on 17 July 2026 at 2300hr. On questioning, the individual was found to be an active Anti National Element of KYKL.

3. Info revealed that the apprehended individual confirmed his association as an active Anti National Element of KYKL. He revealed that he was recruited in 2024 and was taken to Myanmar through the Ukhrul axis, where he underwent 45 days of induction training before being formally inducted into KYKL. He is a resident of Moirangpurel Mayai Leikai, Imphal East, Manipur, and was part of a batch of approx. 70 recruits. He was employed as a cook within the organisation. Initially, he was issued 01 x AK-47 Rifle with 100 rounds and 02 x magazines, however, prior to the infilt, he abandoned the weapon and was carrying 01 x country made pistol and 01 x Motorola communication set.
