2. Acting swiftly on the specific intelligence and maintaining surprise, the coln laid down ambush betn SBP 69/01 & 68/06. During the operation, one individual was seen attempting to cross the IMB from existing fence gap. When challenged, the cadre started running back towards the fence to which ambush party rushed and grabbed him at around 2200 hrs of 18/07/2026. 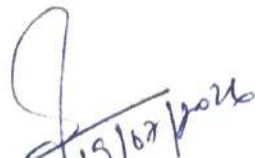
