Subject: Complaint for registration of FIR against Haobam (N) Irom (O) Chitra Devi, wife of O. Loken Singh of Building No. 0386 of Thangal Bazar, Imphal West, and her husband for physical assault on a 63-year-old person, causing facial injury, bleeding, head injury, medical emergency, and joint criminal liability.

Respected Sir,

I, Manoj Kumar Patni, aged 63 years, resident of [insert full address], am submitting this written complaint for registration of an FIR against Haobam (N) Irom (O) Chitra Devi, wife of O. Loken Singh of Building No. 0386 of Thangal Bazar, Imphal West, and her husband for physically assaulting me on 9 June 2026 outside our business premises, M/S Sanmati Traders, Thangal Bazaar, Imphal,

On 9 June 2026, at approximately 3:20 PM, I saw my son, Arihant Kumar Patni, being aggressively confronted outside our store by Haobam (N) Irom (O) Chitra Devi and persons accompanying her. Armed security personnel were also present with her.

I was informed and could see that the matter had started from a minor and accidental shoulder contact between my son and Haobam (N) Irom (O) Chitra Devi while he was walking outside the store area. The said contact happened without any bad intention and was not an intentional touch, especially because the area is a small galli and a narrow path where people are naturally required to pass closely.

My son did not provoke or escalate the matter and attempted to move away. However, Haobam (N) Irom (O) Chitra Devi became aggressive and escalated the matter.

I stepped out only to calm the situation and prevent any further escalation. I did not provoke or assault anyone. My only intention was to defuse the matter and protect my son from further intimidation.

However, Haobam (N) Irom (O) Chitra Devi and her husband suddenly and violently attacked me. I was brutally punched on the face. Haobam (N) Irom (O) Chitra Devi also threw her sandals on my face, in which I was badly hurt and bleeding. Her husband also physically assaulted me with his hands, along with the help of CRPF security personnel. The assault was intentional, aggressive, and completely unprovoked.

The armed security personnel present at the spot did not control the situation. Instead, they abused the power of their uniform by shielding and enabling the aggression. The armed CRPF/VIP security personnel, who was wearing a Blue Safari dress and appeared to be the head or leading person among the security guards present, played the main role in escalating the matter. He abused the power of his uniform and tried to incite and flare up communal words instead of controlling the situation.

As a result of the assault, I suffered head injury, dizziness, bilateral swelling on my face, bleeding, and severe physical and mental trauma. Due to the shock and trauma, my medical condition worsened, and I had to be taken to the Regional Institute of Medical Sciences, Imphal, for emergency treatment. A Medico-Legal Case has been registered vide MLC No. 26/2789, copy enclosed for your records.

The attack on me was particularly serious because I am 63 years old, and the accused persons acted with knowledge that assaulting a senior person in such a manner, including punching him in the face and throwing sandals on his face, could cause serious injury and medical complications.

The incident has been recorded in CCTV footage with video and audio. The footage clearly shows the assault and the role of the accused persons.

If all the videos and CCTV footage are watched carefully, the matter is self-explanatory. It clearly reflects a life-threatening assault, instigation of communal flare-up, and blatant abuse of uniform and authority by the security personnel present at the spot.

I request you to register an FIR against:

1. Haobam (N) Irom (O) Chitra Devi, wife of O. Loken Singh of Building No. 0386 of Thangal Bazar, Imphal West along with her husband O. Loken Singh.
2. All the security personnel who enabled and escalated the incident along with the armed CRPF/VVIP security personnel wearing Blue Safari dress, who appeared to be leading the security guards and played the main role in escalating the situation.
3. Any other person found involved during the investigation.

I request that the matter be investigated from the angle of life-threatening assault, voluntarily causing physical injury, assault on a senior citizen, criminal intimidation, communal provocation, abuse of uniform, and common involvement of all persons who participated in or enabled the assault.

I request you to immediately register the FIR, record my statement, seize and preserve the CCTV footage, obtain my complete medical records from RIMS, and take strict legal action against the accused persons.
