Sir,

I have the honour to report that today i.e. the 1<sup>st</sup> July, 2026 at about 2:00 p.m. received a reliable information from our own source corroborated with the intelligence of 31 AR about the presence of an active member of the outfit PREPAK at Nagamapal area of Imphal West. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops)IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 3:00 p.m. after providing prior information to Imphal West District Police.

In that, one suspicious person was detained for verification at Nagampal Kangjabi Leirak near Public Toilet Complex, Imphal West District. On verification, the detainee identified himself as one **Sorokhaibam Donjao Meitei @ Taibang (44 years) S/o (Late) S. Bomajaoba Meitei of Heikrujam Maning Leikai, Nambol PS, Imphal West District**. On further verification, the detainee stated that he is an active cadre of the outfit PREPAK joined through one Mr. Nonthang of PREPAK in the year 2024 and got his basic military training for 45 days at Tokpa-Ching, Kakching District under the command of the said Nonthang of PREPAK with allotted army no. 2415578 of 55<sup>th</sup> batched of the year 2024. The arrestee is presently holding the rank of s/s - Private and working under the command of one s/s - Captain Mr. Ningthem of PREPAK

So, the detainee was arrested from the spot i.e. Nagampal Kangjabi Leirak near Public Toilet Complex, Imphal West District at 3:35 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
