Subject: Lodging of FIR

Sir,

1. Based on own intelligence, input regarding the likely presence of UKNA camp in general area of SQ 837 located North of Songkong village, Henglep Sub-Division, Churachandpur District, security forces team launched on operation on the night of 12th June, 2026. Upon reaching the designated area, the security forces established a deliberate surveillance of suspected location. During this period, the movement of presence of armed insurgent cadres inside camp were positively identified and confirmed.

2. On 16th June, 2026 at approximately 1430 hrs as security forces party began tactically closing in on camp, the hidden insurgent opened sudden indiscriminate & heavy fire upon the party with automatic weapons, with clear intent to kill.

3. Faced with an imminent threat to life, the security forces returned controlled fire for effect & engaged the insurgents. After a brief & intense exchange of fire, the insurgent firing ceased & the remaining cadres fled into the thick foliage under the cover of terrain.

4. During a subsequent thorough search of immediate engagement area & abandoned camp site, the body of 01 x insurgent unidentified male UKNA cadre was located & led to recovery of significant cache of arms & ammunitions & explosive material hidden at the site at Gen Area Songkong map Sq 4837, Sub-Division Henglep & District – Churachandpur.

5. Following weapons, ammunitions & war-like stores were recovered.

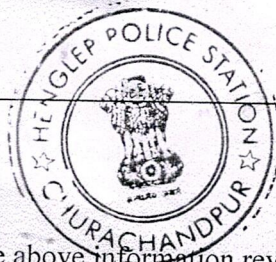
