Subject: Report for registration of FIR case.

1. It is to report that based on Intelligence input from Chandel Police and corroborated from 43rd Assam Rifles, Sajik Tampak regarding the presence of weapons warlike stores (WLS) in the General area of Aigejang, Chandel District, and further corroboration by own sources.

2. Operations Based on the input a search operation was launched by Column of strength 01-01-20 from A Coy and a column of strength 01/01/20 from Rana Top in general area Aigejang on 08/06/2026 at 2330 hrs the Operation column reached general area on 9/6/2026 at 0210 hrs and carried out detailed search. At around 0550 hrs of 9/6/2026 during the search, the team found hidden cache of weapons and huge quantity of WLS was recovered.

3. Details of Recovery

1. One 0.22 rifle with scope.
2. One local made 9 mm Pistol with Magazine
3. Five local made CMG
4. Four local made Lathod gun
5. Explosive approx. (1.2 kg).
6. Three Baofeng sets.
