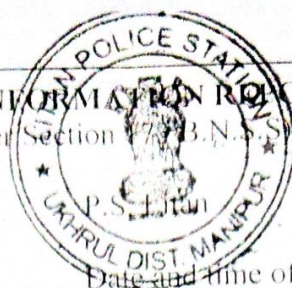

SP Shimreiwung Shimray (44 yrs) SP Paul, resident of Leingangching/Laho Litan Village lodged a complaint regarding a serious incident that occurred on date 8 June 2026 at around 9:15p.m. Suspected Kuki militants open fire in and around the village area, causing panic among the residents. During the shootout, innocence villagers become the victim of the violence, one bullet penetrated through the roof and walls of his house during the firing incident.

Hence a regular FIR No. 39(06)2026 LTN-PS, U/s 109/324(3)/125/351(2) BNS and 25 (1-C) Arms Act is registered for investigation.

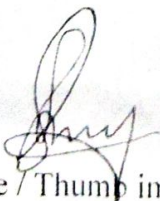

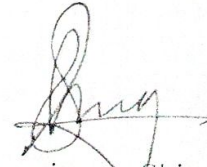
