I have the honour to report that on 19th June, 2026 at around 9:00 a.m., while I along with two others namely: 1. Mr. Masingleng Vashum, S/o Mr. Kapangkhui Vashum, of New Tusom village, Ukhrul District, Manipur and 2. Mr. Wungpam Vashum, S/o Mr. Kapangkhui Vashum, of New Tusom village, Ukhrul District, Manipur were travelling from Ukhrul toward Imphal on NH-202 via Litan by Alto Car Bearing Registration No. MN01AK-4501 to attend a medical emergency of Mr. Masingleng Vashum. We were stop by Kuki Volunteers at Mongkot Chepu. From there, we were forcibly abducted and taken to a house some distance away from the highway and threaten that we would be killed. We pleaded to spare our lives and explained that we took the road due to a medical emergency.

Soon thereafter, Litan Police personnel led by the OC arrived at the spot, had a heated argument with the kidnappers and rescued us. The police party escorted us safely till Yaingangpokpi.

Therefore, your kind authority is requested to register a criminal case against the kidnappers and ensure their punishment as per law of the land.
