Subject: Complaint for immediate legal action against Arya, S/o Manoj,
for crime against a woman, physical assault, misconduct and
intimidation at Thangal Bazar Gully.

Sir,

I, Smt. Haobam Chitra Devi, respectfully submit this complaint for your urgent intervention and immediate legal action against one person namely Arya, S/o Manoj, for committing a serious act of physical assault, misconduct, intimidation and crime against a woman at Thangal Bazar Galli, Imphal.

The incident occurred today, 9 June 2026, at around 3:30 p.m., while I was walking through Thangal Bazar Galli. At that time, the above-named person, Arya, S/o Manoj, acted in an aggressive, unlawful and threatening manner and physically pushed/assaulted me in a public place.

His conduct was highly condemnable and caused serious fear, humiliation, mental distress and insecurity to me. Such an act against a woman amounts to a serious violation of my dignity, bodily safety, personal liberty and right to move freely without fear.

I have my own security personnel/PSO. My PSO immediately tried to protect me from the accused person, but due to the sudden and aggressive nature of the incident, he could not prevent the assault. The conduct of the accused created a serious threat to my safety and dignity. When I asked him why he acted in such manner, he threatened me that he will cause grievous hurt to me if I asked anything regarding the matter. He also blamed me as a woman without moral behaviour.

This incident should not be treated as a minor quarrel. It is a serious act of violence, intimidation and misconduct against a woman in a public place. If such conduct is not acted upon immediately, it may encourage further harassment, intimidation and violence against women.

I therefore request your good office to kindly register this complaint/FIR and take strict and immediate legal action against Arya, S/o Manoj, under the appropriate provisions of law, including provisions relating to assault, use of criminal force, intimidation and offences against women.

I further request you to kindly:

- Register an FIR/complaint against the accused person;
- Conduct an immediate inquiry into the incident;
- Record my statement as the victim/complainant;
- Record the statement of my PSO and other witnesses present at the spot;
- Ensure my safety and protection from any further threat, harassment or intimidation;
- Take strict legal action against the accused person so that such crimes against women are not repeated.

I request your urgent action in the interest of justice, women's safety and public order.

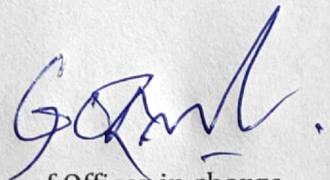
